**Official Notice Board**

Race Officials are using a web-based program to assist with the management of this regatta. It provides electronic forms for such actions as scoring inquiries, protests, equipment substitutions, etc. And it provides for electronic communication with competitors if competitors have provided an email and/or telephone number accepting SMS. Competitors will be notified electronically of protest time limits, confirmation of a protest filing, scheduled hearing times, etc. This electronic system allows competitors to move freely about the event and remain in contact with relevant officials. And all competitors have electronic access to the scoring inquiries, jury decisions, etc.\*

**1. GENERAL INFORMATION**

- 1.1. Race Office will be set at the Anthaven Hotel Marina facilities.
- 1.2. During this race On-the-water judging shall be used. The procedure and penalties will be detailed below;
- 1.2.(a) On-the-water judging will be applied for the rules of Part 2 and rule 31. Judges who are members of the protest committee will blow a whistle when they observe a breach of a rule, and they expect one or more boats to take a penalty.
- 1.2.(b) Action or no action by the judges under this SSIs shall not be grounds for redress. This changes rule 62.1(a).
- 1.3. The sunset time for this Race will be 1942 (local time). (ref:NoR/art1.5)
- 1.4. The documents listed in NoR regarding registration must be send to <http://ticows.com/> on 10<sup>th</sup> April 2024 at the latest, and the original copies must be delivered to the Race Secretariat at 1500 (local). (ref:NoR/art6.2)
- 1.5. Registration and other fees;
- 1.5.(a) Registration fee is EUR400 per boat. (TYF contribution is included in this fee.)
- 1.5.(b) All entry fees are payable to the Tenzor Sailing Club by credit card or by bank transfer. Please ensure the payment reference contains: "team / boat name / sail number".

- 1.6. Payment can also be done on site, during registration confirmation, by cash or credit/debit card and must be transferred to this account with explanation before registration.



- 1.7. Only TSF licensed sailors can participate in this race, "Temporary License" will not be applied. These prescriptions shall not apply to foreign competitors.
- 1.8. Each boat owner/responsible will provide a crew list along with the registration form App.#B. Detection of a competitor on the boat who is not on the crew list or who is not on the boat although his name is on the list may be grounds for disqualification (DSQ) by the Protest Committee.
- 1.9. Every change of a crewmember shall be declared to the Race Office no later than two (2) hours before the scheduled time of the first warning signal of the day. Crew substitution shall be done from Official Online Notice Board. (NP)(DP)
- 1.10. The boat owner or his/her appointed official is responsible for the behaviour and conduct of all team members who register for the races at the race area and accommodation facility and for any social media (including whatsapp group for race information) posts related to the races. In case of any possible inappropriate behavior and/or social media posts/messages, upon the request of the RC, the IJ may impose a penalty, including disqualification, on the boat owner/responsible person together with the person concerned.
- 1.11. The venue is Bitez & Akyarlar Bodrum. (ref:NoR/art.13.1)
- 1.12. Coach/support boats should register to the Race Office before the first race.
- 1.13. For Press/media members should register no later than 10 April 2024
- 2. FORMAT AND PROGRAM OF THE RACES (ref: NoR/art.10)**
  - 2.1. All competing boats have bow number and sail number required by TCA
  - 2.2. The RC will lay a mark for practice 11 April from 1530 to 1730 hrs(local)
  - 2.3. The Skippers' briefing will be held on Friday, 12 April at 1000 at the event area.
  - 2.4. Races will be held in accordance with Nor10.2.(b) RC will endeavour to run a total of eleven (11) races at 12-13 & 14 April 2024.
  - 2.5. On each race day, the warning signal time for the first race of the day will be **1130 hrs (local)**
  - 2.6. The starts will be made in accordance with RRS26 (5 minutes-4 minutes-1 minutes –START).
  - 2.7. No warning signs will be given after 1500, 14 April 2024, on the last day of the races.
