Hearing No. 4 was heard together with Hearing No. 3 in accordance with RRS 63.2 since both hearings arose from the same incident.

Enrico Vaccaro (NJ ITA), Adam Brestovski (coach for SVK 2363) and Stefan Scharnagl (coach for AUT 3060) present as observers.

FACTS FOUND

Wind conditions 8 to 10 knots with small waves

Boats were sailing downwind to the port mark of the gate to be left to starboard.

They entered the zone overlapped with ITA 2622 inside boat AUT 3060 in the middle SVK 2363 outside boat SVK 2363 rounded the mark about 0.5 meters from the mark, ITA 2622 touched the mark with her front part, and both ITA 2622 and AUT 3060 luffed and turn 360 and pass the mark from the required side.

ITA 2622 and AUT 3060 had contact with no damages or injury.

ITA 2622 took 1 turn penalty.

CONCLUSIONS AND RULES THAT APPLY

Rules: RRS 18.2(b), 14, 43.1(c), 31

- 1. SVK 2363, outside overlapped at the zone, failed to give AUT 3060 and ITA 2622 mark-room, and broke RRS
- 2. Since AUT 3060 and ITA 2622 were sailing within the mark-room to which they were entitled, and the contact did not cause damage or injury, they are exonerated under RRS 43.1(c) for breaking RRS 14.
