PROCEDURAL MATTERS

Case no. 1 was heard together with case no. 2 and 3 while they arise from the same incident.

FACTS FOUND

- 1) SIs states individual time limit $APH \times 2,3 \times \text{length of the course}$ and that individual time limits will be published on ONB.
- 2) Time limits calculated as $APH \times 2,0 \times \text{length of the course}$ were published before start on August 24 at 12:05.
- 3) Published time limit for SPIRIT OF GALATEA expired at 06:20:38 on August 26, time limit for FOXY LADY expired at 8:58 and for ALETR EGO at 9:48 on the same day.
- 4) SPIRIT OF GALATEA retired at 04:15 on August 26 when she was 18 NM to the finish, FOXY LADY retired at 6:15 on August 26 when she was on distance 21 NM to finish and ALTER EGO 6:50 on August 26 when she was on distance 21 NM to the finish. Total course length was 72 NM.
- 5) After finishing SPIRIT OF GALATEA find out that time limits published were calculated wrongly, multiplied by 2,0 instead 2,3 and informed RC.
- 6) Race Committee published new correctly calculated time limits on August 26 at 18:41.

CONCLUSIONS AND RULES THAT APPLY

Rules: 62.1, SI 20

- 1) Race committee did an error but results of the boats SPIRIT OF GALATEA, FOXY LADY and ALTER EGO was made worse by retiring through their own fault. Therefore, the requirements for redress in RRS 62.1 are not met.
