PROCEDURAL MATTERS

- 1. The panel of the International Jury was constituted in accordance with RRS N1.4(b).
- 2. Parties of Case 9, HKG 171979 was represented by Nicholas Halliday, IND 218191 was represented by Saravanan Vishnu and IND 212161 was represented by Mohit Saini .
- 3. Although Case 9 was invalid, HKG 171979 Nicholas Halliday reported there was an allegation of team racing, which is misconduct, the panel decided to consider whether there was a need to call a hearing under RRS 69 or not, in accordance with RRS 69.2(b).
- 4. Video evidence was presented by HKG 171979.
- 5. Tracker evidence was presented by the jury.

FACTS FOUND

- 1. The wind was around 9 knots and the water was choppy.
- 2. While rounding the last leeward mark, IND 212161 did a slow and wide rounding.
- 3. IND 218191 did a narrow and fast rounding, between IND 212161 and the mark.
- 4. HKG 171979 had already rounded the mark around 25 seconds before.
- 5. While sailing the last leg towards the finish, IND 212161 and IND 218191 were competing to out sail each other.
- 6. IND 218191 finished ahead of IND 212161.
- 7. HKG 171979 finished 25 to 30 seconds before IND 218191 and IND 212161.

CONCLUSIONS AND RULES THAT APPLY

Rules: RRS 69.1(a), 69.2(b)

- 1. There was no evidence found to conclusively prove that IND 212161 sailed to benefit IND 218191 to the detriment of her own position.
- 2. The actions of IND 212161 did not qualify as a breach of the recognised principles of sportsmanship and fair play, as per Para 56.1.4 of World Sailing Misconduct Guidance 2021. IND 212161 did not break RRS 69.1(a).

DECISION

A hearing under RRS 69.2(b) is not called.
