#### 1. RULES

- 1.1 Each regatta will be governed by the "rules" as defined in the Racing Rules of Sailing (RRS) 2021-2024. The prescriptions of the National Authority will not apply.
- 1.2 Class rules.
- 1.3 In case of conflict the English version will prevail.

## 2. SAILING INSTRUCTIONS

#### 4. ELIGIBILITY AND ENTRY PROCEDURE

- 4.1. Competitors shall comply with World Sailing Eligibility Code (Regulation 19).
- 4.2 Each helm shall be a current member of ITA or an ITA recognized National Tempest Association.
- 4.3 **Registration** shall be made at this link:

https://fragliavela.sailti.com/en/default/races/race/text/TempestEurocupMalcesine-en , no later than 26<sup>th</sup> of April (24:00h). To complete registration, it is compulsory to send by email at <a href="race@fragliavela.org">race@fragliavela.org</a> all the requested documentation (boat insurance and for Italian sailors: class membership and FIV membership) no later than 26<sup>th</sup> of April (24:00h).

All crews must have signed the registration form in the secretary before Friday 28th of April at 11.00.

- 4.4 Crew substitution of the registered sailor is not allowed.
- 4.5 Any sailor who has not completed the registration by the closing time for registration finalization, will be removed from the list of sailors of the event and will not be scored at that event.





#### 5. ENTRY FEE

5.1 Entry fee, if paid before the 14<sup>th</sup> of April 23.59h: 300€

Entry fee, if paid from the 15th of April 00.00: 330 €

The entry fee shall be paid by **bank transfer** (Bank fees shall be paid by entrant. Wire details will be sent after the online registration) or by **Paypal** (the entrant has to **pay €5** for **Paypal fees**). At the Club payment by cash or credit card are NOT accepted.

5.2 Cancellation policy: For registration annulation before the 14<sup>th</sup> of April the entry fee paid will be refunded 80%. For notifications after the 14<sup>th</sup> of April, 50% of the entry fee paid will be refunded. After the 26<sup>th</sup> of April no entry fee will be refunded.

#### 6. AVERTISING

- 6.1 Advertising shall comply with World Sailing Advertising Code (Regulation 20).
- 6.2 Boats may be required to display advertising chosen and supplied by the organizing authority.

#### 7. COMPETITION FORMAT

- 7.1 For the series 8 races are scheduled. 3 races per day are scheduled.
- 7.2 A fourth race can be sailed only when in delay with the program or when the forecast suggest that no race can be sailed in the next day.

#### 8. SCHEDULE

8.1 Event Schedule

**Thursday, April 27<sup>th</sup>** Race office opening (10.00-12.00/14.00-18.00)

Friday, April 28<sup>th</sup> Skippers meeting at 11.00

First warning signal at 13.00

After races – Pasta party and beer

Saturday, April 29<sup>th</sup> Races

After races – Pasta party and beer

**Sunday, April 30**<sup>th</sup> Races, Prize-giving at the end of the races

8.2 On the last scheduled day of racing, no warning signal will be made after 15.30.

#### 9. MEASUREMENTS

- 9.1 Prior measurements are not scheduled.
- 9.2 All boats, sails and equipment shall be already measured. No damaged sail or equipment shall be substituted with another measured sail or equipment without a prior permission written by the technical committee or RC if the TC is not nominated. The TC or RC reserve the right to conduct measurement checks afloat or ashore.

#### **10. BOATS AND EQUIPMENT**

Sails shall have the full sail number and NATIONAL LETTERS in accordance with the Class Rules and the RRS. The national letters shall denote the National Authority of which the sailor is a member in accordance with RRS 75.2 and with the Notice of Race clause 4.1 Eligibility and Entry Regulations. This changes RRS Appendix G 1.1.

### 11 VENUE

- 11.1 Attachment A shows the Club Area.
- 11.2 The intended race-course area will be in front of the Club. See Attachment B.

#### 12. RACE COURSES

The course will be a trapezoid course or a windward-leeward course.





#### 13. PROTESTS AND PENALTY SYSTEM

- 13.1 Decisions of the jury will be final as provided in rule RRS 70.5.
- 13.2 Scoring penalties will be applied as specified in sailing instructions.

#### 14. SCORING

- 14.1 The Low Points Scoring System of RRS Appendix A will apply.
- 14.2 2 races are required to complete the regatta.
- 14.3 When fewer than 8 races have been completed, a boat's series score will be the total of its race scores.
- 14.4 When 8 races or more have been completed, a boat's series score will be the total of her race scores excluding the worst score.

#### 15. TEAM AND SUPPORT BOATS

Team and support boats shall, at all times when afloat, be conspicuously identified by the identification flag provided by the Organizing Authority. They must fill an accreditation form available online at this link: https://fragliavela.sailti.com/en/default/races/race/text/TempestEurocupMalcesine-en.

#### 15. RIGHTS TO USE NAME AND LIKENESS

By participating in this event, competitors automatically grant to the organizing authority and the event sponsors the right, in perpetuity, to make, use, and show at their discretion, any photographs, audio and video recordings, and other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.

#### 16. LIABILITY

- 16.1 RRS 3 states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone". Therefore, the participants are aware that the sailing activity falls within those governed by Article 2050 of the Italian Civil Code and that all participants must have a valid FIV membership that guarantees accident coverage, including death and permanent disability
- 16.2 The sailing club, national authority, their officers, members and volunteers do not accept liability for loss of life or property, personal injury or damage caused by, or arising out of, the regattas.
- 16.3 The establishment of the Notice of Race and the Sailing Instructions in no way limits or reduces the complete and unlimited responsibilities of a competitor being solely and entirely responsible for the management of a boat he or she is sailing.

## **17. INSURANCE**

- 17.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of 1.500.000 € per event or the equivalent. A proof of it shall be sent by email at <a href="mailto:race@fragliavela.org">race@fragliavela.org</a> to complete registration.
- 17.2 Each competitor is wholly and exclusively responsible for third party liability insurance on the boat that he or she is sailing and for his or her personal accident and health insurance.
- 17.3 Each competitor is wholly and exclusively responsible to maintain his boat in a safe and seaworthy condition checking it before going afloat.

#### 18. PRIZES

Prizes will be awarded to the top 5 crews classified. Other prizes at the discretion of the Organizing Authority.

#### **19. SAFETY**

Competitors shall wear personal flotation devices at all times when afloat, except briefly when changing or adjusting clothing or personal equipment. Wet suits and dry suits are not personal flotation devices. This changes rule RRS 40.





#### **20. LOGISTIC INFORMATION**

20.1. Boats trailers and cars may park in the sailing club parking lots from Wednesday, April 26<sup>th</sup> until Monday, May 1<sup>st</sup>. It is forbidden to park Camper, Vans, either during the day or overnight, within the limits of the Fraglia Vela Malcesine private area.

20.2 Please enter with the trailers from the North Entrance of the Club and not from the main entrance of the car park. We will publish the map of the logistic planning for the regatta.

#### **20.3 TRAINING AT FRAGLIA VELA MALCESINE:**

Free hospitality at the Club from Wednesday, April 26th until Monday, May 1st.






