PROCEDURAL MATTERS

Original Hearing

- 1. USA did not come to the hearing, the hearing proceeded in accordance with RRS 63.3(b).
- 2. POR is represented by Filipe Rafael Lopes.

Reopening:

- The hearing was reopened on 13th December in accordance with RRS 63.3(b), because the protest committee decided that USA was unavoidably absent at the original hearing because USA was not properly called at the time of the hearing
- 2. The reopened hearing was held with 3 Judges (Ilca, Santiago, Marton) in accordance with RRS N1.4
- 3. USA Coach attended the hearing as an observer. (Ana Tunniclaffe)

FACTS FOUND

Original Hearing

- 1. First upwind leg, wind up to 7 knots.
- 2. POR and USA were sailing close-hauled on a collision course, POR on starboard tack and USA on port tack.
- 3. USA kept her course.
- 4. POR bore away sharply and passed 30 cm behind the stern of USA.
- 5. Neither boat took a penalty.

Reopening:

The hearing was reopened on 13th December in accordance with RRS 63.3(b), because the protest committee decided that USA was unavoidably absent at the original hearing because USA was not properly called at the time of the Hearing

- 1. USA requested the GPS data to be used as evidence. SI 17.1 forbides GPS data to be used as evidence.
- 2. First upwind leg, wind up to 7 knots with small waves.
- 3. POR and USA were sailing close-hauled on a collision course, POR on starboard tack and USA on port tack.
- 4. USA kept her course.
- 5. At about half a boat wide distance, POR bore away sharply and passed 1 meter behind the stern of USA.
- 6. Neither boat took a penalty.

CONCLUSIONS AND RULES THAT APPLY

Rules: RRS 10

1. USA on port failed to keep clear of POR on starboard, and broke RRS 10.

USA is DSQ in race 2.
