PROCEDURAL MATTERS

Arbitration Inappropriate - The incident includes a request for redress

FACTS FOUND

- 1. Class 2 and Class 3 race as one single class, starting at the same time, with the same course to be sailed. See SI 4. The Sailing Instructions do not explicitly state that Class 2 and Class 3 are scored together but that is the intention, agreed by both classes before the season began.
- 2. The course set for Class 2 and Class 3 was 322. The order of marks and sides to be passed was as follows: Z C D P C I
- 3. The RC shortened the course for Class 3 and Class 4 at Mark D. The shortened course was signalled from a RIB making sound signals and displaying the S Flag and Class 3 and Class 4 flags.
- 4. Class 3 boats 680 and 9541 were finished and timed at the D mark per the results sheet attached.
- 5. The RC shortened the course for Class 2 at Mark P. The shortened course was signalled from a Committee Vessel making sound signals and displaying the S Flag and Class 2 flag.
- 6. Class 2 was finished and timed at the P mark per the results sheet attached.

CONCLUSIONS AND RULES THAT APPLY

Rules: SI 4, RRS 28.1, RRS 62.1(a)

- 1. By sailing the course, C3 complied with RRS 28.1
- 2. By sailing the course, C2 complied with RRS 28.1
- 3. By not explicitly stating that Class 2 and Class 3 are scored as one, it was reasonable for the Race Officer to assume that Class 2 and Class 3 could have been scored separately and they could have sailed different or shortened courses.
- 4. The scores of the C2 boats in the race were made significantly worse through no fault of their own by an improper action or omission of the Organising Authority.

Redress is given to Class 2 boats as follows
