## **FACTS FOUND**

- 1. Race 4 at the end of leg 1.
- 1.1. The Protest Committee boat was located on the continuation of the starboard layline 4-5 boat lengths from the mark.
- 1.2. 216000 approached the mark on starboard tack.
- 1.3. 216000 started rounding the mark and bearing away.
- 1.4. 216000 accelerated and touched the mark with her boom, sail, and the middle of port side of her hull.
- 1.5. 216000 was in a contact with the mark for 2-3 seconds.
- 1.6. 216000 took no penalty.
- 2. Race 4 at the end of leg 2.
- 2.1. The Protest Committee boat was located to starboard of the run looking downwind at the mark 4-5 boat lengths from the mark, 1-2 boat lengths upwind from the mark.
- 2.2. 216000 approached the mark on port tack.
- 2.3. 216000 started rounding the mark and luffing.
- 2.4. 216000 touched the mark with the port side of her hull just before the mast.
- 2.5. 216000 was in a brief contact with the mark.
- 2.6. 216000 took no penalty.
- 3. Race 6 at the end of leg 2.
- 3.1. The Protest Committee is not convinced that there is enough evidence to prove that 216000 touched the mark.
- 4. Race 7 at the end of leg 1.
- 3.1. The Protest Committee is not convinced that there is enough evidence to prove that 216000 touched the mark.
