PROCEDURAL MATTERS

- 1. The panel of the International Jury was composed in accordance with RRS N1.4(b).
- 2. SUI 171 was represented by Elena Lengwiler
- 3. Matthew Gerolet (coach for SUI) attended as an observer.
- 4. FRA 174 did not come to the hearing, the hearing proceeded in accordance with RRS 63.3(b).
- 5. SUI 171 presented video footage taken from her GoPro.

FACTS FOUND

- 1. SUI 171 was sailing downwind on port gybe.
- 2. FRA 174 was sailing downwind on port gybe ahead of SUI 171.
- 3. In an unrelated incident, FRA 174 decided to take a One-Turn Penalty.
- 4. FRA 174 bore away gybed to starboard, crossing in front of SUI.
- 5. FRA 174 then altered course to windward and, just to leeward and in front of SUI, raised her kite to tack.
- 6. SUI 171 lifted her kite and altered course to windward, but her kite collided with FRA's kite.
- 7. SUI 171 kite collapsed and her strings got twisted with other strings from her own kite. There was no physical damage.
- 8. Neither boat finished the race.

CONCLUSIONS AND RULES THAT APPLY Rules:

- 1. While taking a penalty turn, FRA 174 failed to keep clear of SUI 171, and broke RRS 21.2.
- 2. Since FRA 174 retired, she took an applicable penalty, she is not further penalized under RRS 64.2(a).
- 3. SUI 171 score was not made significantly worse by physical damage, therefore the requirements for redress under 62.1(b) are not met.
