## Notice of Race (NoR)

Revision 1: Sail Canada Code of Conduct is replaced with CORK / Sail Kingston Code of Conduct in 1.6 (May 15, 2023)

Revision 2: Start time of warning signal on first race of the day changed to 1200 (July 6, 2023)

The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

#### 1 RULES

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 [DP] RRS 40.1 applies and is amended so that it applies at all times while afloat.
- 1.3 The following national prescription may require advance preparation: RRS 46 – Person in Charge – Sail Canada prescribes that the designated person in charge, if resident in Canada, shall be a member of Sail Canada through either a club affiliated to Sail Canada or such person's Provincial Sailing Association.
- 1.4 RRS Appendix T "Arbitration" will apply.

- 1.6 The CORK / Sail Kingston Code of Conduct found within the Safe Sport Policy Package applies and found at: <u>https://cork.org/wp-content/uploads/2023/05/CORK-Safe-Sport-Policy-Package-2023-03-21.pdf</u>

#### 2 SAILING INSTRUCTIONS

2.1 The sailing instructions will be posted on the online official notice board.

#### 3 COMMUNICATION

- 3.1 The online official notice board is located at: Official Notice Board
- 3.2 [DP] While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

#### 4 ELIGIBILITY AND ENTRY

- 4.1 For boats to be accepted for this event, the online registration form must be completed and all fees must be received by 1800 July 6, 2023. No entries will be accepted after this time.
- 4.2 This event is open to all foiling multihulls, Windfoilers, and iQ Foils.
- 4.3 A minimum of 5 boats makes a class. Expected one design classes include A Class, F18, F101, iQFoil, Wind Foil (Open).
- 4.4 The Organizing Authority reserves the right to group similar boats together to form one or more classes.
- 4.5 Eligible competitors may enter by completing the online form and submitting it through the event website <u>www.cork.org</u>.
- 4.6 [NP] A competitor that competes with a bib or sail number she is not registered with or received permission from the race committee to sail with will receive a 10% scoring penalty as calculated in RRS 44.3 (c) added to the race score sailed nearest in time to that incident. This changes RRS 63.1.
- 4.7 All sailors and support personnel under the age of 18 must have their parent or guardian sign acknowledgement and acceptance of risks form (Appendix 1)
- 4.8 All sailors and support personnel 18 years of age or older must sign the waiver and release of liability form (Appendix 2)
- 4.9 To complete the entry process, participants must pay all fees and complete the attached checklist (Appendix 3).

#### 5 FEES AND REFUNDS

- 5.1 The entry fee covers racing, site use from July 7 9, 2023, and a regatta souvenir.
- 5.2 Support personnel are required to be registered online. Coaches are required to be registered online with fee paid prior to the event to be eligible to coach. Coaches fees cover site use from July 7-9, 2023 and a regatta souvenir.

- 5.3 In the case of event cancellation or postponement by CORK, all fees except for bank charges will be refunded.
- 5.4 All fees except for bank charges will be refunded to boats that cancel prior to June 30, 2023.

#### 6 [DP] ADVERTISING

- 6.1 Boats may be required to display advertising chosen and supplied by the organizing authority. If this rule is broken, World Sailing Regulation 20.9.2 applies.
- 6.2 Numbered bibs will be provided for competitors which must be worn while racing.

7.1 Five races are scheduled per day. The race committee may run two extra races on a day provided that they do not get more than one race ahead of the daily schedule and do not exceed the number of races scheduled for the event.

#### 8 EQUIPMENT INSPECTION

- 8.1 iQFoil competitors shall submit a completed equipment registration form before 1100 hours on July 7, 2023
- 8.2 Competitors are required to comply with RRS 78.1 from the time of the first scheduled warning signal until the end of the event.
- 8.3 Upon arriving ashore, a competitor may be instructed by a member of the race committee or the technical committee to proceed immediately to a designated area for inspection.
- 8.4 Substitution of damaged or lost equipment will not be allowed unless authorized by the race committee. Requests for substitution shall be made at the first reasonable opportunity.

#### 9 VENUE

9.1 Launch site for iQFoil and WindFoil Open will be Lake Ontario Park Sailing will be in Lake Ontario South of Lake Ontario Park. All other classes will launch from Portsmouth Olympic Park with sailing taking place on Lake Ontario South of POH.

#### 10 COURSES

10.1 The courses to be sailed will be a windward/leeward configuration.

#### 11 PENALTY SYSTEM

11.1 RRS 44.1 and RRS P2.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty unless the incident occurs within the zone in which case, the Two-Turn Penalty will apply.

#### 12 [DP] [NP] SUPPORT PERSONNEL AND VESSELS

- 12.1 Support persons shall register online and if their entry is approved, present a form (Appendix 4) containing the boats they are supporting to the onsite check in point.
- 12.2 All support personnel shall comply with CORK's Support Team Regulations at: <u>Support Team</u> <u>Regulations</u>
- 12.3 Support persons are required to monitor the CORK course channel on their VHF radios and be available to assist with safety when requested. The VHF channel will be stated in the sailing instructions.
- 12.4 Coaches are expected to attend the coaches meeting each morning. The sailing instructions may give additional requirements for support persons on the water.

#### 13 [DP] LAUNCHING

13.1 Competitors shall launch from and return to Lake Ontario Park

#### 14 DISCLAIMER OF LIABILITY AND RISK STATEMENT

RRS 3 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone." Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

- (a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event.
- (b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore.
- (c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omission.
- (d) Their boat is in good order, equipped to sail in the event and they are fit to participate.
- (e) The provision of a race management team, patrol boats and other officials and volunteers by the event organizers does not relieve them of their own responsibilities.
- (f) The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.

#### 15 INSURANCE

15.1 Each participating boat shall be insured with valid third-party liability insurance. The organizing authority does not accept any responsibility for verifying that a boat has valid third-party liability insurance.

#### 16 PRIZES

- 16.1 CORK will provide a variety of prizes depending on the number of competitors in the fleet. Some class associations may provide their own additional prizes.
- 16.2 Medallions will be awarded to the top 3 competitors.
- 16.3 Other awards may be given.
