1. Sven Witschel attended the hearing representing Lena LY.

- 2. Ignacio Campos attended the hearing representing Tanit.
- 3. Original decision given at 19:15 on 03 August 2023.
- 4. Original panel composition: Giorgio Davanzo, Andres Perez and Miguel Allen.
- 5. During the night, the Jury had a conversation with a member of the Race Committee who observed the incident; based on her evidence, the Jury decided that it might have made a significant error in deciding the case and reopened the hearing as provided in RRS 66.1.

## Reopened hearing:

- 1. Matthias Kramer represented Lena in the reopened hearing.
- 2. Laia Vadell (RC member) attended as witness.

## **FACTS FOUND**

## **Original Facts Found:**

- 1. The wind was around 15 knots with 1 meter waves.
- 2. About 2 to 3 minutes after the start, Lena (Swan 40) was sailing upwind on starboard tack and Tanit (Grand Soleil 37) was sailing upwind on port tack on a collision course.
- 3. Tanit luffed and initiated a tack that would put them to leeward of Lena.
- 4. Before Tanit passed head to wind, Lena bore away sharply.
- 5. The closest distance between the boats was, at least, 5 meters.
- 6. There was no collision and no boat took a penalty.

## Facts Found after the Reopening:

- 1. Lena displayed the red flag 3 minutes after the incident.
- 2. The red flag was inside the cockpit and any crew member could have displayed the flag immediately after the incident.
