The Organizing Authority (OA) of the races is J/70 Turkiye Class Associating (J/70 TCA).

GENERAL INFORMATIONS

- This Notice of Race covers the **2022 Tour of Turkiye** races to be organized by J/70 TCA with the sponsorship of D-Marin.
- Race details for each leg will be announced separately before the races in a **Supplement** for the leg.
- The Race Office will be set as stated in the **Supplement**
- The notation ‘[DP]’ in a rule in the Notice of Race (NoR) means that the penalty for a breach of that rule may, at the discretion of the Protest Committee, be less than disqualification.
- The notation ‘[NP]’ in a rule of the Notice of Race means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a)
- The notation ‘[SP]’ in a rule in the Notice of Race (NoR) means that the penalty for a breach of that rule may, at the discretion of the Race Committee without hearing. This changes RRS 63.1, A4 & A5.

1) RULES

- 1) The “Rules” as defined in the World Sailing Racing Rules of Sailing, RRS 2021-2024
- 2) J/70 Class Rules 2022
- 3) The J/70 TCA 2022 Standard Sailing Instructions, the applicable Supplement and amendments.
- 4) If there is a conflict between the rules above, the Standard Sailing Instructions, Supplement and their amendments will be valid according to their date. This changes RRS 63.7.
- 5) The times of sunset and sunrise will be stated in the **Supplement**
- 6) Only for T.C. Citizens: TYF Sporcu Lisans, Tescil, Vize ve Transfer Talimatı, Disiplin Suçları ve Cezaları Talimatı. These prescriptions shall not apply to foreign competitors.
- 7) All crews are required to follow all the latest Covid-19 guidance from TSF and the Government.
- 8) Times shown are local (GMT+ 2 /Istanbul)
- 9) If there is a conflict between texts, Turkish text shall take precedence unless otherwise stated in the **Supplement**

2) SAILING INSTRUCTIONS

- 1) The Standard Sailing Instructions (SSIs), together with the **Supplement** will be available on the website www.j70tr.org & <https://www.racingrulesofsailing.org/events/3307>

3) COMMUNICATION

- 1) The Online Official Noticeboard (ONB) is located on the website at www.racingrulesofsailing.org. There will be no physical ONB.
- 2) [DP]All boats shall carry a VHF radio capable of receiving all normal International Marine VHF Channels.
- 3) [NP]On the water the Race Committee will make courtesy broadcasts to competitors on VHF radio (ch) 74
- 4) [DP]From the first Warning Signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions nor receive voice or data communication that is not available to all boats.
- 5) WhatsApp may be used to draw attention to the ONB.

4) ELIGIBILITY

- 1) The race is open to the members of J/70 Class as defined by the J/70 Class Rule.
- 2) The entire crew, including the owner/driver, shall provide proof of a valid World Sailing Group 1 classification at the time of registration (J/70 Class Rule I-4).

5) ENTRY

- 1) Eligible boats shall complete & send the required entry form to j70kayit@gmail.com and pay the entry fee.
- 2) Entries shall be submitted before the date as announced with the **Supplement**
- 3) All competitors are required to complete the following:
 - (a) Entry Form.
 - (b) Crew list, TSF licence (For Turkish Citizens only) and World Sailing Sailor ID (IF ANY).
 - (c) COVID-19 Personal Declaration Form.

6) FEES

- 1) 2022 TCA Annual fee of the TCA is TL2.000 (including 2022 class sticker)
- 2) Non-Owner driver's fee is TL500
- 3) Group 3 crew fee for each is TL250
- 4) Protest & Request of Redress fee is TL500
- 5) The entry fee for each leg is TL2.000
- 6) The entry fee must be received before the date as announced with the **Supplement**

7) CREW LIMITATIONS

- 1) J70 class rules shall apply.
- 2) TSF license is required for only Turkish citizens.
- 3) A Valid Covid-19 vaccine pass or PCR test (the result should be received within 48hrs. at latest) are required for all competitors.

8) ADVERTISING

- 1) [DP]Advertising is permitted in accordance with TSF regulation, J/70 Class Rules and World Sailing Regulation 20.
- 2) [DP]Boats may be required to display advertising chosen and supplied by the Organizing Authority.

9) [NP]SCHEDULE

- 1) The Schedule of Races will be stated in the **Supplement**.
- 2) The Race Committee intends to run;
 - (a) Eight (8) races for each leg,
 - (b) Eleven (11) races for Turkish Championship
 - (c) Total Fifty-one (51) races during the Tour of Türkiye.
 - (d) The maximum number of races to be held in one racing day will be three (3).
 - (e) However, the RC may change the schedule of the races to accommodate adverse weather conditions.
- 3) First warning signal time will be 1200 for each racing day.
- 4) The time of the last Warning signal on the last day of each leg will be stated in its **Supplement**.

10) EQUIPMENT INSPECTION

- 1) Each boat shall comply with the International J70 Rule.
- 2) Boats may be inspected at any time.
- 3) Re for Turkish Championship; All competing boats will be subject to measurement.

11) CLOTHING AND EQUIPMENT

- 1) [DP] RRS 50 shall apply.

12) VENUE

- 1) Venue will be as stated in the **Supplement**
- 2) The approximate position of the Committee Vessel will be announced by VHF (ch) 74 radio and WhatsApp.

13) COURSES

- 1) The format for racing will be windward/leeward courses. See Addendum A.

14) PENALTY SYSTEM

- 1) RRS 44 shall apply.

15) SCORING

- 1) For the series;
 - (a) One race shall be completed to constitute a series.
 - (b) When fewer than five (5) races have been completed, the boat series score shall be the total of all her scores.
 - (c) When five or more races have been completed, the boat series score shall be the total of her race scores excluding her worst score.
- 2) See SSIs' App#1 for Tour of Türkiye.

16) SUPPORT VESSELS

- 1) All support vessels shall carry a marine VHF radio and comply with RRS 37 'Search and rescue Instructions'.
- 2) [DP]Support boats shall stay outside areas where boats are racing from the time of the preparatory signal for each start thereafter until all boats have finished or retired or the Race Committee signals a postponement, general recall or abandonment.

17) CHARTERED OR LOANED BOATS

- 1) RRS G3 applies.

18) BERTHING

- 1) All registered J70s may moor at the marina which is stated in the **Supplement**.
- 2) Event berthing is the responsibility of each boat and is not included in the entry fee.
- 3) Visiting boats should contact J/70 TCA for berthing reservations.

19) HAUL OUT RESTRICTIONS

- 1) [DP]All boats shall be afloat during the first race day 0900 hrs (local)
- 2) Boats shall not be hauled out during the event except with and according to the terms of prior written permission of the race committee.

20) DIVING EQUIPMENT AND PLASTIC POOLS

- 1) [DP] Except with prior written permission of the race committee, underwater breathing apparatus and plastic pools or their equivalent shall not be used around competing boats between the preparatory signal of the first race and the end of the event.

21) DATA PROTECTION

- 1) The J/70 TCA, in compliance with the General Data Protection Regulations (GDPR), will use information provided by competitors for the purposes of J/70 TCA event management only. This data will be held in compliance with the GDPR and will not be shared with any third parties or used for marketing purposes other than contacting competitors by email, post, SMS and telephone with information regarding this event or future events. Competitors will be required to provide their specific consent to this on their entry form.
- 2) Competitors automatically grant to the Organizing Authority, without payment, the right in perpetuity to make, use and show any motion pictures, still pictures and live, taped or filmed television of or relating to the event provided that they do not infringe the privacy rights of participants.

22) RISK STATEMENT

- 1) Competitors and support teams participate in the series entirely at their own risk and they are reminded of the provisions of RRS 3, Decision to Race. Sailing is by its nature an unpredictable sport and therefore involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:
 - (a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event,
 - (b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore,
 - (c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
 - (d) By participating in any race, they are satisfied that their boat is in good order, equipped to sail in the event and they are fit to participate;
 - (e) The provision of a race management team, patrol boats and other officials and volunteers by the organizer does not relieve them of their own responsibilities;
 - (f) It is their responsibility to familiarize themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event and to attend any safety briefing held for the event.
- 2) J/70 TCA, Protest, Technical & Race Committee and all parties involved in the event organization will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the event.

23) INSURANCE

- 1) Each participating boat and the crew must be insured with sufficient insurance cover to meet all or any claims and third party coverage.
- 2) Boats shall have adequate and suitable insurance before racing.

24) PRIZES

- 1) Prizes will be awarded for the first, second and third boats in the series.
- 2) Additional prizes may be awarded according to the Organizing Authority's decisions.

25) FURTHER INFORMATION

- 1) There will be an un-official WhatsApp group for receiving general information from the Race Office. The QR Code will be provided to boats entered in the event.
- 2) Further information requests should be sent to the OA.
