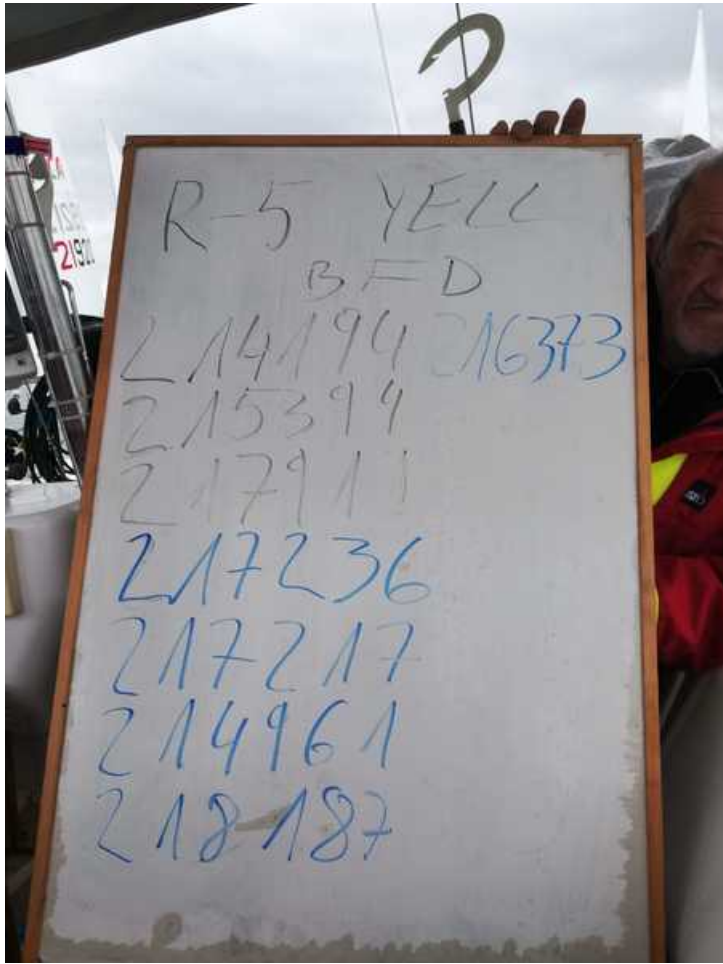

PROCEDURAL MATTERS

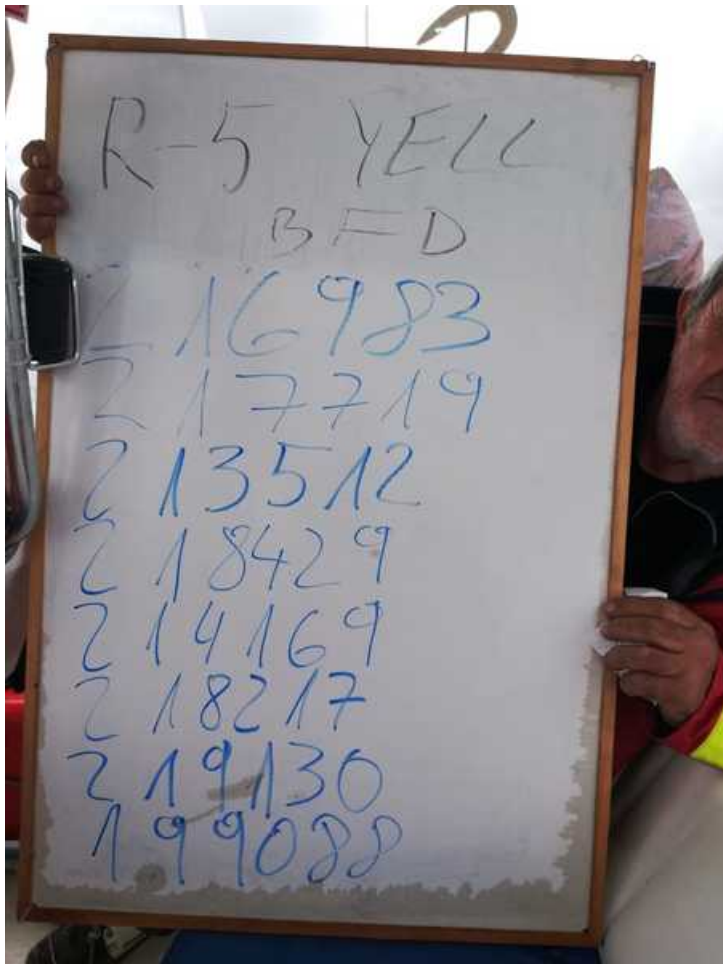
After racing Race committee discovered a mistake in the results, New fleet assignments were posted at 9.00. The request for redress was lodged at 10.06.

FACTS FOUND

1. Race Nr 5 was started under RRS 30.4
2. Start of yellow fleet IND 217719 was identified in the triangle formed by the starting line and mark one within the last minute before the starting signal.
3. A general recalled was signalled.
4. The sailnumber of IND 217719 was displayed on the board
5. The board was shown for at least 3 minutes before the next warning signal signal.
6. IND 217719 sailed in the restarted race.
7. After racing IND 217719 adressed the race office and requested a retirement after finish.
