PROCEDURAL MATTERS

1-Hearing No.6 was heard together with Hearing No.7 inaccordance with RRS 63.2 since both hearings arose from the same incident

2-FRA 49 did not come to the hearing, the hearing proceeded inaccordance with RRS 63.3(b).

FACTS FOUND

1-USA 47 and FRA 49 were sailing on port tack towards the starting line to start with FRA 49 15 metres to leeward and 20 metras ahead of USA.

2-GBR 43 was sailing on starboard tack and on colisión course with FRA 49. Close to FRA 49, GBR 43 bore away sharply and passed behind of FRA 49.

3-At that point, USA 47 and GBR 43 were on head to head colisión course. Inmediately after, USA 47 bore away sharply. 4-There was contact between USA 47's and GBR 43's kites. Several lineas were broken in both kiteboards. There was no tangle.

5-FRA 49 retired of the race after finishing.

6-USA 47 and GBR 43 could not finish the race (N5).

CONCLUSIONS AND RULES THAT APPLY

Rules: 63.2, 63.3.b, 10, 14

1-FRA 49 on port did not keep clear of GBR 43 on starboard breaking RRS 10.

2-GBR 43, right of way, changed the position of her kite without giving room to USA 47 to keep clear, breaking RRS 16.1. 3-It was not reasonably possible for GBR 43 and USA 47 to avoid the contact, therefore they did not break RRS 14. 4-Since GBR 43 was compelled to break RRS F2.16.1 as a consequence of FRA 49 breaking RRS 10, she is exonerated under RRS 43.1(a) for this breach.

5-The score of USA 47 and GBR 43 was made significantly worse in race 5 through no fault of her own by damage caused by the action of a kiteboard that was breaking a rule of part 2 and took an appropriate penalty or was penalised. Therefore the requirements of RRS 62.1(b) are met.

6-By starting on port when other kiteboards were starting on starboard, FRA 49 intentionally broke RRS 10, clearly violating the recognized principles of sportsmanship and broke RRS 2.
