- 1. Wind was 8-10 kts. Sea was calm.
- 2. During the start, Pepper & Salt (P&S) and Zoe were on port tack. P&S was on the leeward side of Zoe around 2 boat lengths apart. Noah was on starboard tack. Noah and P&S were sailing on a converging course.
- 3. Zoe tacked away to avoid collision.
- 4. Noah shouted "We are on Starboard". The closet distance between Noah and P&S was around 1 boat length. Noah tacked to become port tack and avoided collision.
- 5. No boat collision
- 6. P&S took two turns penalty

P&S on port failed to keep clear of Noah on starboard, and broke RRS 10.

Zoe kept clear from P&S and did not break RRS 11.
