1. RULES

1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing.

1.2 The Class Rules of each class and those of their Class Associations apply.

1.3 The ETF26 will also race as part of their 2023 European Class Series rules, so those series rules will also apply.

1.4 In all rules governing the event, the terms sailor, competitor, crew and rider means a person competing or intending to compete in this regatta.

1.5 In addition, the Wingfoil class, IWSA will race under updated World Sailing experimental rules DR21-05 Appendix WF dated June 2021. Special division called _X15_ with provided equipment will be run under the same rules.

1.6 Boats may be required to display advertising chosen and supplied by the organizing authority.

2. SAILING INSTRUCTIONS

2.1 Sailing Instructions will be available online at <https://www.racingrulesofsailing.org/documents/6382/event?name=foiling-week-2023> and <https://fragliavela.sailti.com/en/default/races/race/text/FoilingWeek2023-en> from the 27th of June 2023.

No printed copy will be provided by the OA.

3. OFFICIAL NOTICE BOARD

4. ELIGIBILITY AND ENTRY

4.1 The regatta is open to boats/boards of the International Moth, Waszp, ETF26, One Fly, Flying Phantom, BirdyFish, and Wingfoil class. The 69F class will also race during Foiling Week, but under a separate NoR which has already been published.

4.2 The event is limited to a maximum of 80 Moths, 80 Waszps and 50 Wingfoils. For all other classes the entries are not limited. Entries will be accepted by the first come, first served principle and payment is mandatory at the moment of entry. No entry can be completed without payment.

4.3 All boats have to comply with their own class rules and all Int. Moths must have a valid measurement certificate.

4.4 All competitors shall be members of their National Class Association or the International Class Association where there is no appropriate national class association.

4.5 The helmsperson/ competitor/rider named on the entry form shall be the same for all races.

4.6 All competitors/runners may be required to wear a bib, if required it would be provided by the Organizing Authority. All bibs must be worn during the race and on the outside of all clothing.

4.8 Online entries will close on June 26th, 2023.

4.9 All documents related to the registrations (boat insurance and payment receipt) must be sent by email at race@fragliavela.org by 11.59 pm of the 26th of June 2023, specifying the Class and Sail Number in the Object.

5. FEES

5.1 Early entry fee, if paid before the 18th of June at 23.59

The entry fee must be paid by bank transfer (wire details for registration will be sent after the online registration and bank fees shall be paid by entrant) or by PayPal (**PayPal commission has to be paid by entrant**). **Payments cannot be made at the club by cash or credit card.**

5.2 Cancellation policy: For entries cancelled before the 18th of June at 23.59 the entry fee paid will be refund 90%. For notifications after the 19th of June at 00.00 and before the regatta 50% of the entry fee paid will be refunded. After the 27th of June no entry fee will be refunded.

6. SCHEDULE

6.1 Please refer to Appendix A – which sets out the proposed training and racing schedule for each class, along with the planned number of races.

6.2 The scheduled time of the first warning signal on the 28th of June 2023 is 13.00hrs.

6.3 The maximum number of races to be sailed for each class will be:

ETF – 20

Moth – 16

Waszp – 16

One Fly – 16

Flying Phantom – 12

BirdyFish – 6

Wing Foil – 20

6.4 There will be no warning signal made after 16.00hrs on the last day of each class's racing. Prizegiving will take place as soon as possible after the last race for each class.

6.5 A schedule of social events will be posted with the Sailing Instructions.

7. MEASUREMENT

7.1 Each boat shall produce a valid measurement certificate for all equipment and sails at registration if requested.

7.2 Int Moth: Maximum of 2 sails, 2 masts, 2 front foils (vertical & horizontal) and 2 rear foils (vertical & horizontal) shall be used.

7.3 Waszp: Every sailor, shall declare at the before the start of the Foiling Week whether he/she is using an 8.2m or 6.9m sail, and this cannot be changed during the regatta.

7.4 Other class measurement requirements will be set out in the Sailing Instructions.

7.5 A schedule of social events will be posted with the Sailing Instructions.

7.6 Boats may be subject to inspections at any time during the regatta.

8. VENUE

8.1 The event will be held at Fraglia Vela Malcesine. Via Gardesana 205, Frazione Navene - 37018 Malcesine, Italy. Wingfoils will be based on the Kite Surfing Club at Navene beach, approximately 500m north of the FVM marina.

9. THE COURSES

9.1 The courses to be sailed will be described in the Sailing Instructions.

10. PENALTY SYSTEM

10.1 RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty for all classes other than the Wingfoil riders who must complete a 360 deg turn ie. one tack and one gybe but without jumping.

11. SCORING

11.1 The Low Point System of Appendix „A“ will apply for all classes other than – ETF26 and Wingfoil – see 12.1.5 and 12.1.6 below.

11.2 When fewer than 5 races have been completed, a boat’s score will be the total of her race scores.

11.3 When from 5 to 10 races have been completed, a boat’s series score will be the total of her race scores excluding her worst score.

11.4 When 10 to 15 races have been completed, a boat’s series score will be the total of her race scores excluding her two worst scores.

11.5 When more than 16 races have been completed, a boat’s series score will be the total of her race scores excluding her three worst scores.

11.6 Wingfoils – the scoring for this class will be set out in the Sailing Instructions once the level of entries has been finalized and the racing format agreed.

11.7 ETF26 class will be scored in accordance with their 2023 European Class Series rules.

12. SUPPORT BOATS

12.1 Support boats shall be registered with the Organizing Authority online at <https://fragliavela.sailti.com/en/default/races/race/text/FoilingWeek2023-en> and shall display always the white flag with the red “S”, given by the Club.

13. BERTHING

13.1 Boats shall be kept in the assigned places at the boat park.

14. RADIO COMMUNICATION

14.1 The ETF26 class IS permitted the use of a radio. For all other classes - Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

15. PRIZES

15.1 Prizes will be awarded to the top three or more competitors for each class.

15.2 Additional prizes may be given at the discretion of the Organizing Authority.

16. MEDIA RIGHTS, CAMERAS AND ELECTRONIC EQUIPMENT

16.1 By participating in Foiling Week 2023, competitors automatically grant the Organizing Authority and their sponsors, the right in perpetuity to make, use and show, from time to time at their discretion, any motion pictures and live, taped or filmed television and other reproductions of the athlete during the period of the competition without compensation.

16.2 Boats may be required to carry cameras, sound equipment or positioning equipment as specified by the Organizing Authority.

16.3 The top three (3) competitors, as well as the individual race winners, may be required to attend a media press conference each day.

16.4 Competitors may be required to be interviewed during the regatta.

17. LIABILITY

17.1 As per RRS.3, the regatta participants take part in the regatta under their full and sole responsibility, the Competitors and their support persons are the only responsible for the decision to take part or to continue the race; the Organizers decline any and all liability for damages that may occur to persons and / or things, both ashore and offshore, as a result of their attendance at the regatta covered by this Form; it is competitors task and their support people task to decide according to their abilities, the wind, the sea conditions, the weather forecasts and everything else should be forecasted by a good sailor, whether to go offshore and take part the regatta, to continue it or to quit it.

18. INSURANCE

18.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of €1.500.000 per incident or the equivalent. This must be sent prior to June 26th to the OA via e-mail race@fragliavela.org , specifying the Class and Sail Number in the Object.

19. SUSTAINABLE EVENT

19.1 Foiling Week is a World Sailing Special Event Sustainability Charter signatory. The event will uphold and report against the 10-point Charter to align and support the objectives of Worlds Sailing's Sustainability Agenda 2030.

20. HOSPITALITY

20.1 Boats, Trailers and Cars will be hosted in the Yacht Club grounds **2 days prior to the beginning of the races of their respective class**. For classes racing from the 28th of June, no boats can be hosted before Monday 26th.

20.3 Camper Vans are not allowed in the parking area of the Yacht Club (both during the day and the night).
