### PROCEDURAL MATTERS

1. FRA 12414 was represented by Timothe Lesniak.
2. Jonathan Dumont, coach of FRA 12414 attended the hearing as an observer.
3. Based on the information in the written request, the International Jury proceeded with Case No. 18 as a request of redress as permitted by RRS 64.1(c).

### FACTS FOUND

1. On the 19th of July, at 21:18 the International Jury published the decision of Hearing No. 10.
2. Redress has been given to NZL 12569 for races 9, 8 and 7, subject to WS Case 116.
3. The results for the U15 Gold fleet, which included the redress to NZL 12569 were posted on the 20th of July at 20:40.
4. FRA 12414 saw the results on the Official Notice Board on the 21st of July at 11:00.
5. After seeing the results, FRA 12414 talked with his coach and then attended the team briefing for the day. The team briefing lasted approximately 15 minutes.
6. After the briefing, FRA 12414 talked again with his coach in order to decide how to proceed.
7. FRA 12414 lodged a request of redress on the 21st of July at 12:04.

### CONCLUSIONS AND RULES THAT APPLY

**Rules:** RRS 62.2, 63.5, 64.1(c).

FRA 12414 failed to deliver the request for redress as soon as reasonably possible after learning of the reasons for making it, as required by RRS 62.2. There was no good reason for the International Jury to extend the time. Therefore, the requirements for a valid request for redress are not met, and the hearing is closed under RRS 63.5.
