## **PROCEDURAL MATTERS**

- 1. On 15 Dec 2023, at 19:06, CHN 661 filed a scoring inquiry claiming a change in her scoring position. The RC's decision was to make no change to the boat's score and was notified on 15 Dec 2022, at 22:05. Subsequently, CHN 661 filed this request for redress based on the same claim on 16 Dec 2023, at 12:52
- 2. CHN 661 was represented by Huicong Mai.
- 3. Race Committee was represented by Chandra Shekar Dalai.

#### **FACTS FOUND**

- 1. CHN 661 lodged a scoring enquiry on 15th Dec at 19:06 after the results were posted.
- 2. A reply was given on 15th Dec at 22:05 from RC which was seen by the requesting party later that night on the 15th.
- 3. CHN 661 arrived at the venue at about 10:00 on the 16th and met his foreign coach.
- 4. CHN 661 stays 10 minutes walking distance from the venue.
- 5. He met his Chinese coach to help fill in the form around 11:00 on the 16th.
- 6. The Chinese coach of CHN 661 also stays at the same location.
- 7. The request for redress was lodged on 16th Dec at 12:52.
