PROCEDURAL MATTERS

Five Jury members were online and one was physically present. First hearing was held at Civitavecchia on 31/08/2021 and the second hearing was held without the parties present on 04/09/2021 under RRS 63.3.

FACTS FOUND

1- All boats were provided by the OA.

- 2- All teams signed a handover paper stating the boat was delivered by the OA as 'ready to sail'.
- 3- All teams spent 3 days with Figaro coach at France.

4- All teams made approx.300 miles delivery trip as seatrial from Calais/France to Genoa/Italy.

5- Team USA 1 had two problems during delivery: 1) Port autopilot (B&G Triton 2) software problem. 2) Port foil extraction not to full, but to 2/3.

6- Team USA 1 informed the OA about the problems via whatsapp.

7- At Genoa, some teams stated problems about B&G's autopilot software.

8- OA's technician solved both problems of team USA 1 at Genoa by rebooting the software of B&G and changing the ine of the foil.

9- He also rebooted the software of the other team's B&G's who had problems too.

10- All boats were 'ready to sail' at Genoa.

11- All boats started at 13:05 on 28/08/2021.

12- Team USA 1 again had a foil problem of the port foil getting inside the hull totally in the morning of the 3rd racing day.

13- Team USA 1 finished on 30/08/21 at 10:05 as the 10th boat amongst 10 boats and had the best place of 8th for some time.

14- Team USA 1 informed OA when arrived ashore about the foil problem and requested redress to the int.jury on 30/01/21 at 14:11 via email.

15- OA technician found again the line being damaged as the reason of the malfunction of the foil and fixed it again.

16- No other boat had any such problems in the first race.

17- Team USA 1 sailed twice in Figaro 3 prior to this race.

18- Team USA 1 will race in the second race starting on 01/09/2021 at 17:00.

19- Team USA 1 scored last in the second race.

20- Team USA 1 did not report any problems regarding their boat on the second race of the race.
