## **Notice of Race (NoR)**

NP - All participants, hereinafter defined as competitors, Support Persons (as defined in the RRS), coaches, officials, staff, and volunteers, are advised that the [Sail Canada Safe Sport Policy Package](#) is in effect for this championship.

At the time of registration all participants shall sign the [Office of the Sport Integrity Commissioner \(OSIC\) Consent Form](#). All participants shall be designated as [Universal Code of Conduct to Prevent and Address Maltreatment in Sport \(UCCMS\) Participants](#) and shall be subject to the conditions in the UCCMS Consent.

The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

## 1 RULES

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 [DP] RRS 40.1 applies and is amended so that it applies at all times while afloat.
- 1.3 The following national prescription may require advance preparation:  
*RRS 46 – Person in Charge – Sail Canada prescribes that the designated person in charge, if resident in Canada, shall be a member of Sail Canada through either a club affiliated to Sail Canada or such person's Provincial Sailing Association.*
- 1.4 RRS Appendix T "Arbitration" will apply.
- 1.5 The Sail Canada Prescriptions can be found at [https://www.sailing.ca/wp-content/uploads/2022/06/sail\\_canada\\_prescriptions\\_2021\\_2024\\_14\\_03\\_2022.pdf](https://www.sailing.ca/wp-content/uploads/2022/06/sail_canada_prescriptions_2021_2024_14_03_2022.pdf)
- 1.6 A boat that sails with a sail number she is not registered with or received permission from the race committee to sail with will receive a 10% scoring penalty (RRS44.3). This changes RRS 63.1 and RRS A5.

## 2 SAILING INSTRUCTIONS

- 2.1 The sailing instructions will be posted on the online official notice board.

- 3.2 [DP] While racing, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

## 4 ELIGIBILITY AND ENTRY

- 4.1 **For boats to be accepted for this event, the online registration form must be completed and all fees must be received by 1800 August 7, 2023. No entries will be accepted after this time.**
- 4.2 The regatta is open to boats of the ILCA 4, ILCA 6, ILCA 7, and Club 420, and 29er classes.
- 4.3 Eligible boats may enter by completing the online form and submitting it through the event website [www.cork.org](http://www.cork.org).
- 4.4 All sailors and support personnel under the age of 18 must have their parent or guardian sign acknowledgement and acceptance of risks form (Appendix 1)
- 4.5 All sailors and support personnel 18 years of age or older must sign the waiver and release of liability form (Appendix 2)
- 4.6 To complete the entry process, participants must pay all fees and complete the attached checklist (Appendix 3)

- 8.1 The race committee may run one extra race on a day provided that they do not get more than one race ahead of the daily schedule and do not exceed the number of races scheduled for the event.

## 9 VENUE

- 9.1 Sailing will be in Lake Ontario South of Portsmouth Olympic Harbour. ILCA classes will sail on one course and the Club 420 and 29ers will sail on another course.

## 10 COURSES

- 10.1 The courses to be sailed will be windward / leeward or ILCA class trapezoid.

## 11 [DP] [NP] SUPPORT PERSONNEL AND VESSELS

- 11.1 Support persons shall register online and if their entry is approved, present a form (Appendix 4) containing the boats they are supporting to the onsite check in point.
- 11.2 All support personnel shall comply with CORK's Support Team Regulations at: <https://cork.org/wp-content/uploads/2023/06/CORK-Support-Team-Regulations-V3-2023-06-07.pdf>
- 11.3 Support persons are required to monitor the CORK course channel on their VHF radios and be available to assist with safety when requested. The VHF channel will be stated in the sailing instructions.
- 11.4 Coaches are expected to attend the coaches meeting each morning. The sailing instructions may give additional requirements for support persons on the water.

## 12 [DP] BERTHING

- 12.1 Boats shall be kept in their assigned places/area while they are in the boat park.

## 13 DISCLAIMER OF LIABILITY AND RISK STATEMENT

RRS 3 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone." Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:

- They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event.
- They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore.
- They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omission.
- Their boat is in good order, equipped to sail in the event and they are fit to participate.
- The provision of a race management team, patrol boats and other officials and volunteers by the event organizers does not relieve them of their own responsibilities.
- The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.

## 14 INSURANCE

14.1 Each participating boat shall be insured with valid third-party liability insurance. The organizing authority does not accept any responsibility for verifying that a boat has valid third-party liability insurance.

## **15 PRIZES**

15.1 CORK will provide a variety of prizes depending on the number of competitors in the fleet. Some class associations may provide their own additional prizes.

15.2 Medallions will be awarded to the sailors of the top 3 Sail Canada Youth Nationals finishing boats overall.

15.3 Sail Canada Youth Championships awards will be presented by Sail Canada. Sail Canada Senior Championships awards will be presented by Sail Canada.

15.4 Other awards may be given.
