1. Hearing request 24 is a duplicate of hearing request 23 as it was erroneously re-entered by SGP. These two requests will be heard together.

FACTS FOUND

- 1.Results are posted on the official notice board via a link to the results at https://info.hangzhou2022.cn/en/results/sailing/daily-schedule.htm.
- 2. The scorer posted the results from the sailwave program at 1405Hrs
- 3. The same sailwave result was posted on the official results web site at 1408Hrs 23Sep2023
- 4. From the official notice board results link, this result of the iQFoil Women Class race S12 would have been available at 1408Hrs 23Sep2023
- 5. The request for redress was filed at 0926Hrs on 24Sep2023, a time of 19hours and 18 minutes after the results was posted on the ONB
- 6. The results posted at 1408Hrs 23Sep2023 of race S12 includes a score of BFD for CHN and HKG and a DNF for SGP (THA is 1st and PHI 2nd).
- 7. SGP admitted she was partially at fault for not checking the result earlier because her phone battery was dead and that she wanted to isolate herself from results.
- 8. SGP was made aware of 2 BFD scores in race S12 by her team support person at about 9am in the morning of 24Sep2023 after which she submitted a request for redress at 9.26am.
