PROCEDURAL MATTERS

GER 3634 did not come to the hearing, the hearing proceeded in accordance with RRS 63.3(b).

FACTS FOUND

- 1- 7-8 knots, flat sea.
- 2- At race number 9, 1 min before start, HUN 37 sailing on port gybed to starboard.
- 3- HUN 37 became the closest boat to the pin end and sailed on starboard parallel to and below the starting line.
- 4- 2 boat lengths below the pin end, GER 3634 who was positioning herself below the pin end for the last 3 minutes by tacks and gybes, began to sail on port tack 10 seconds to the start towards the starting line.
- 5-7 secs before the start, GER 3634 was half a boat length to the starboard side of the pin end and below the starting line.
- 6- GER 3634 luffed till her jib flapped and slowed down.
- 7- GER 3634 sailed the same way at the earlier starts.
- 7- HUN 37 luffed to starboard and had a slight contact with no damage with GER 3634's starboard side.
- 8- RC on pin end identified HUN 37 as BFD.
- 9- HUN 37 left the race course as per SI 1.14.

CONCLUSIONS AND RULES THAT APPLY

Rules: 13, 2, 62.1.(d)

- 1- After passing head to wind and before being on a close-hauled course, GER 3634 failed to keep clear of HUN 37 . GER 3634 broke RRS 13.
- 2- By knowingly breaking rule 13 and not taking the appropriate penalty, GER 3634 failed to compete in compliance with the principles of sportsmanship and fair play, and broke RRS 2.
- 3- HUN 37 is entitled to redress as her score has been made significantly worse through no fault of her own.

DECISION

1- GER 3634 DNE from race no9.

2- HUN 37 is given redress as per Appendix A9(b).
