PROCEDURAL MATTERS

Hearing No. 1 was heard together with hearing No. 2 in accordance with RRS 63.2 since both hearings arose from the same incident

Lesley Anderson and Felix Ng declared that they were competitors in the Kowloon cup

Felix Ng agreed to interpret

FACTS FOUND

At the start signal, the wind was around 10kts. HKG201 was fetching the committee boat end of the line, 3 lengths below. HKG1698 was to leeward of her, and calling her up. HKG692 was positioned to windward, closer to the line, also fetching the committee boat end of the line.

After the start signal HKG201 continued to the line, keeping clear of HKG1698 to leeward of her, passing close to the committee boat.

On the other hand, HKG692 sailed to the line on the upwind side of HKG201.

HKG201 passed close to the committee boat with a gap of 6" at the beam.

After HKG201 had half cleared the stern of the committee boat, the bow of HKG692 hit the starboard guarter of HKG201, causing a scratch (see photo). HKG692 hit the stern of the committee boat on her starboard side midships.

At the time of contact, the gap between HKG201 and HKG1698 (to leeward) was 18-24".

CONCLUSIONS AND RULES THAT APPLY

Rules: 11,14

- HKG692 to windward failed to keep clear of HKG201 to leeward, and broke RRS 11.
- HKG692 did not avoid contact when it was reasonably possible, and broke RRS 14.
