PROCEDURAL MATTERS

FACTS FOUND

ESP940 on starboard tack and ESP1116 on port tack were beating upwind.

ESP1116 bore away to sail behind the stern of ESP940.

When ESP1116 passed behind the stern of ESP940, the helmsman lost the tiller and the boat broached and made contact between the bow of ESP1116 and the stern of ESP940.

One stansion of the pushpit came loose from the deck, part of the pushpit bended and the backstay fitting was damaged. ESP940 continued racing but the crew was not able to hike properly.

ESP940 also sailed the following race (F4) with no possibility to hike properly.

ESP1116 took a penalty turn after the incident.

CONCLUSIONS AND RULES THAT APPLY

Rules: RRS 10, 14

ESP1116 on port failed to keep clear of ESP940 on starboard, and broke RRS 10.

There was serious damage to ESP940

ESP1116 failed to take an appropriate penalty which was to retire.

ESP940 is entitled to redress.

DECISION Date & Time: 2022-08-04 20:18 CEST

The Protest is Upheld

ESP1116 is DSQ in race F3.

Redress is given to ESP940. ESP940 is to be scored in race F3 and F4 points equal to the average, rounded to the nearest tenth of a point (0.05 to be rounded upward), of her points in all races sailed except races F1, F3 and F4 before the last scheduled day of the final series. This shall not be worse than 7, her finishing position in races F3 and F4. No other boat's score shall change.
