PROCEDURAL MATTERS

FACTS FOUND

- 1. Race 3 of gold fleet, first downwind leg.
- 2. POL 26 and CHN 76 were sailing starboard on a downwind course.
- 3. At the zone of the leeward mark, POL 26 was overlapped inside and to windward of CHN 76.
- 4. Both kiteboards were sailing to the mark.
- 5. CHN 76 was aiming 3 meters leeward of the mark.
- 6. Just before the mark, CHN 76 raised her kite and luffed.
- 7. POL 26 was still overlapped and contact occured between POL 26 and the mark and between POL 26's kite and
- 8. No damage, no tangle, no injury, no boat took a penalty.

CONCLUSIONS AND RULES THAT APPLY

Rules: F18.2, 11, 14, 43

- 1. CHN 76 outside overlapped at the zone failed to give POL 26 mark-room, and broke RRS F2.18.2(a)(1).
- 2. POL 26 to windward failed to keep clear of CHN 76 to leeward, and broke RRS 11.
- 3. Since POL 26 was sailing within the mark-room to which she was entitled and the contact did not cause damage, injury or a tangle, she is exonerated under RRS 43.1(c) for breaking RRS 14.
- 4. Since POL 26 was sailing within the mark-room to which she was entitled she is exonerated under RRS 43.1(b) for breaking RRS 11.
- 5. CHN 76 did not avoid contact when it was reasonably possible, and broke RRS 14.
- 6. Since CHN 76 was the right of way kiteboard and the contact did not cause damage, injury or a tangle, she is exonerated under RRS 43.1(c) for breaking RRS 14.

DECISION

CHN 76 is DSQ in race F3.
