BPI Corregidor Cup 2023

The Regatta Organising Authority is the Ocean Racing Club of the Philippines in conjunction with Corregidor Foundation and Caylabne Bay Resort & Marina, under the auspices of the Philippine Sailing Association, and in partnership with WWF Philippines.

1 Rules

- 1.1 The Regatta will be governed by the 'rules' as defined in The Racing Rules of Sailing.
- 1.2 The following will apply:

The IRC Rules 2023 (for IRC Keelboats)

The Cruiser Class Rating System as administered by the Organising Authority

The Offshore Special Regulations Category 5 (for Keelboats)

This Notice of Race (as amended by the Sailing Instructions)

The Sailing Instruction

2 Advertising

- 2.1 The Regatta is designated as a "Category C" event in accordance with World Sailing Regulation 20, Advertising Code.
- 2.2 The organizing committee may require all boats to display the Regatta sponsors advertising on their boats.

3 Eligibility and Entry

3.1 The Regatta will have the following classes:

IRC Racing Class: Keelboats with an IRC Rating Certificate. The class will be divided into divisions based on suitable rating bands at the discretion of the Race Committee.

Cruising Class: Keelboats of a cruising nature not currently holding an IRC Certificate, holding a PSA Cruising Handicap Rating.

Ocean Multihull Class: Ocean Multihulls of a size, type and condition acceptable to the Race Committee, and with an OMR Rating.

Classic Yacht Class: Boats designed on or before 1985.

3.2 The Race Committee shall determine at its sole discretion the rating bands and divisions for the IRC Class.

- 3.3 The Race Committee may not accept an entry for a Class and may allocate any entry to another class or division if it considers that the competition would be better served by the change.
- 3.4 Competitors should compete and return the attached Entry Form so that gate passes and IDs can be prepared to facilitate entry and exit to Caylabne Bay Resort & Marina. A boat approaching the Marina must call on **Marine VHF Channel 69.**
- 3.5 Mooring and berthing is free of charge. For reservations, contact the Marina at least 24 hours before arrival.

4 Official Notice Board

The Official Notice Board will be at the Caylabne Marina Race Office. Information will also be available through the following channels: Corregidor Cup Viber Group, Signature Yacht Race Series Facebook, Signature Yacht Race Series Instagram, Signature Yacht Race Series Webpage.

5 Entry Fees

- 5.1 The Entry Fee is **PHP 12,000** per boat. No additional fees per crew.
- 5.2 The Entry Fee will include attendance at four social events including skipper and all registered crew; BPI Competitor's Kit with various souvenir items; and free berthing at Caylabne.
- 5.3 The Entry Fee must be paid in full before a boat starts to race.

7 Berthing

Boats shall be kept at their assigned berths or moorings in Caylabne Marina and will anchor at the designated area at Corregidor South Beach.

8 Race Courses

- 8.1 The course to be sailed will be island courses with no short windward / leeward courses.
- 8.2 Courses will be set depending on the wind direction and strength between St Nicholas Shoals in the East and Mona Island in the west, off Corregidor Island.

9 Sailing Instructions

The Sailing Instructions will be sent to registered boats and will be available at the Registration.

10 Scoring

The Low Point scoring system of Appendix A in the RRS will apply. A boat's score for the BPI Corregidor Cup 2023 will be the total of all her race scores.

11 Protests

- 11.1 The Chairman of the Protest Committee will be an international juror, and members of the Protest Committee will be appointed.
- 11.2 When the Protest Committee decides that a boat which is party to a protest has broken a rule and is not exonerated, it may impose a scoring penalty (which may be no penalty) at its discretion, as an alternative to disqualification. This changes RRS 64.2.

12 Prizes and Trophies

- 12.1 The **BPI Corregidor Cup Perpetual Trophy** will be awarded to the Overall Winner of the IRC Racing Class in the Corregidor Cup.
- 12.2 Trophies and Prizes will be given to the Overall First, Second and Third Places in each class.
- 12.3 Prizes will be awarded to the First, Second and Third place in each race.
- 12.4 Additional prizes may be given at the discretion of BPI Private Wealth and ORCP.

13 Disclaimer
