PROCEDURAL MATTERS

1. Bruno De Wannemaeker, chairman of the Technical Committee, attended the hearing as translator for FRA 20.

2. Ivica Dolenc, coach of CRO 36, attended the hearing as observer.

FACTS FOUND

- 1. The conditions at the time of the incident were 10 knots of wind and flat water.
- 2. After rounding mark 3, FRA 20 and CRO 36 were sailing on starboard-tack with FRA 20 being 5 metres clear ahead and 4 metres to leeward of CRO 36.
- 3. FRA 20 lifted her kite and tacked to port tack.
- 4. At the same time that FRA 20 lifted her kite, CRO 36 also lifted her kite and bore away.
- 5. Approximately three seconds after FRA 20 had put her kite up, contact occurred between CRO 36's kite and the lines of FRA 20 for three seconds.
- 6. Both competitors fell into the water, recovered later and finished the race.
- 7. No damage, tangle or injury occurred to either kiteboard.
- 8. Neither kiteboard took a penalty.

CONCLUSIONS AND RULES THAT APPLY

Rules: RRS 10, 14, 62.1(b)

- 1. FRA 20 on port failed to keep clear of CRO 36 on starboard, and broke RRS 10
- 2. FRA 20 did not avoid contact when it was reasonably possible, and broke RRS 14.
- 3. It was not reasonably possible for CRO 36, the right-of-way boat to avoid contact with FRA 20 when it was clear that FRA 20 was not keeping clear. CRO 36 did not break RRS 14.
- 4. CRO 36's place in race 8 was not made worse by physical damage or injury. Therefore, the requirements for redress in RRS 62.1(b) are not met.

- 1. FRA 20 is DSQ in race 8.
- 2. Redress is not given.
