



# Sailing Instructions ILCA 6,7 UKLA Master Qualifier Parkstone Yacht Club 22 - 23 April 2023

The Organising Authority (OA) is the Parkstone Yacht Club (PYC) together with the UKLA.

The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a)

#### 1. RULES

- 1.1 The event is governed by the rules as defined in the Racing Rules of Sailing
- 1.2 RRS Appendix T, Arbitration, will apply.
- 1.3 Boats shall comply with the ILCA Class Rules. [DP]
- 1.4 Where there is a conflict between the Notice of Race and the Sailing Instructions, the Sailing Instructions shall prevail. (This changes RRS63.7).
- 1.5 The following Rules have been changed Appendix A 5.1, A5.2, A10, RRS 30.4, 33, 35, 61.1b, 62.1a, 62.2, 63.1, 63.7.

#### 2. CHANGES TO SAILING INSTRUCTIONS

2.1 Any change to the sailing instructions will be posted not less than 30 minutes before flag D is displayed, except that changes to the schedule of races will be posted before 19.00 on the day before it will take effect.

# 3. COMMUNICATIONS WITH COMPETITOR

- 3.1 Notices to competitors will be posted on the Official Notice Board, which is online at Official Notice Board
- 3.2 The race office is located at Parkstone YC sailing office.
- 3.3 [DP] While racing from the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.
- 3.4 Please join the Competitor WhatsApp group.
- 3.5 The competitor briefing will be at 10:00 am on 22<sup>nd</sup> April 2023. Competitors will be advised via the WhatsApp group of a location.
- 3.6 A full list of links may be found in Appendix B.

# 4 CODE OF CONDUCT

4.1 Competitors and support persons shall place advertising provided by the organising authority with care, seamanship, in accordance with any instructions for its use and without interfering with its functionality.

## 5 SIGNALS MADE ASHORE

- 5.1 Signals made ashore will be displayed on the flagpole adjacent to the Tally Hut
- 5.2 When flag AP is displayed ashore, '1 minute' is replaced with 'not less than 30 minutes.
- Flag D with one sound means 'The warning signal will be made not less than 30 minutes' after flag D is displayed. **Boats shall not leave the slipway until the signal is made [DP]**





# 6 SCHEDULE OF RACES

- 6.1 Registration will take from 0830 to 1000hrs on Saturday 22<sup>nd</sup> April 2023 in Training Room 2 at the club.
- 6.2 The scheduled time of the warning signal for the first race each day is:

Date	Schedule	Max number of Races/day	Time of first warning signal	High Water
22/4/23	3 Races	4 races	1155	1058hrs and 1447hrs
23/4/23	3 Races	4 races	1025	1133hrs and 1459hrs

- 6.2 To alert boats that a race or sequence of races will begin soon, the orange starting line flag will be displayed with one sound at least five minutes before the first warning signal is made.
- 6.3 Each day succeeding races will be started as soon as practicable after the finish of the previous race
- 6.4 On the last scheduled day of racing, no warning signal will be made after 1500. If starting multiple fleets, this time deadline will be amended to allow subsequent starts of the same race later than this deadline.

# 7 CLASS FLAGS

The class flags for each class will be as follows:

Fleets	Class Flag	Intended Start sequence. (May change)
ILCA 7	<b>ILCA</b> <sub>TM</sub>	First Start
ILCA 6	<b>HCA</b> <sub>TM</sub>	Second start

#### 8 RACING AREAS

The intended racing area will be the top triangle area of Poole Harbour.

## 9 COURSES

- 9.1 The diagrams in SI Appendix A show the course options to be sailed with the order in which the marks are to be passed and the side on which each mark is to be left.
- 9.2 The course and number of laps to be sailed will be displayed on the Race committee signal vessel.
- 9.3 The approximate bearing of mark 1 may be displayed on the Race committee signal vessel.
- 9.4 If a gate is replaced by a single mark, it is to be left to port.

#### 10 MARKS

- 10.1 Marks 1, 2, 3s, 3p, 4s and 4p, 1a will be inflatable Orange Triangular shape.
- 10.2 The starting mark will be either an official vessel displaying an orange flag or the course side of a dan buoy displaying an orange flag.





10.3 The finishing mark will be either an official vessel displaying a blue flag or on the course side of dan a buoy displaying a blue flag.

# 11 OBSTRUCTIONS [DP]

- 11.1 Boats shall keep clear of, and not impede, all vessels that are constrained in their ability to manoeuvre. These vessels have right of way at all times. The chain ferry in the harbour entrance is such a vessel.
- 11.2 When a commercial vessel or a vessel which is constrained in their ability to manoeuvre is escorted by a Harbour master's vessel or by an Official Vessel displaying IC flag 'U,' boats shall not pass between the Harbour master's vessel or the Official Vessel displaying flag 'U' and the vessel they are escorting.
- 11.3 Boats shall comply with signals and directions given by the escorts.
- 11.4 SI 11 always applies whilst afloat, including when sailing to and from the course area. Any breach of this SI 11 may result in disqualification from the event. This changes RRS 63.1.

#### 12 THE START

- 12.1 Races will be started by using RRS 26 with the warning signal made five minutes before the starting signal.
- 12.2 The starting line will be between a staff on the race committee signal vessel displaying an orange flag and the starting mark.
- 12.3 A boat that does not start within four minutes after her starting signal will be scored Did Not Start without a hearing. This changes RRS A5.1 and A5.2.
- 12.4 Rule 30.4 (Black flag rule) is amended as follows.

  At the sole discretion of the Race committee, they may display the last four numbers of the sail number, for brevity provided there is no ambiguity.
- 12.5 Boats whose warning signal has not been made shall remain a minimum of one hundred metres from the start line during the start sequence of the previous fleets [DP]

# 13 CHANGE OF THE NEXT LEG OF THE COURSE

- 13.1 To change the next leg of the course, the race committee will move the original mark.
- 13.2 Minor mark moves, up to approximately 100m in any direction, may be made without signalling the change. This changes RRS 33.

#### 14 THE FINISH

- 14.1 The finishing line will be between a mast displaying blue flag on the race committee signal vessel and the finishing mark.
- 14.2 The race committee may score boats based on their relative positions at a mark of the course or on a leg of the course as follows:
  - 14.2.1 When an official boat displays flag W with two sounds, boats still racing may be scored as their observed position on the race course.
  - 14.2.2 When a boat is scored in accordance with this instruction, she shall be given a score for a place after all boats that have sailed the course and finished. This changes RRS A4 and A5.
- 14.3 The Finishing Window is the time for boats to finish after the first boat sails the course and finishes. Boats failing to finish within the Finishing Window, and not subsequently retiring, penalized, given redress, or scored with a "W" flag in 14.2 above, will be scored Time Limit Expired (TLE) without a hearing. A boat scored TLE shall be scored points for the finishing place one more than the points scored by the last boat that finished within the Finishing Window or under 14 "W" flag above. This changes RRS 35, A5.1, A5.2 and A10.

# 15 PENALTY SYSTEM

# 16 TIME LIMITS

16.1 The time limits and target times are as follows:

Time limit Mark 1 time limit Target time	Finishing Window

16.2 If no boat has passed Mark 1 within the Mark 1 time limit the race will be abandoned. Failure to meet the target time will not be grounds for redress. This changes RRS 62.1(a).

#### 17 HEARING REQUESTS

- 17.1 In addition to RRS 61.1(a) a boat intending to protest should notify the finish boat immediately upon finishing the race or retiring and await acknowledgement.
- 17.2 Protests/Redress shall be lodged online via the online Jury system located at Racingrulesofsailing.org
  Protests and requests for redress or reopening shall be delivered there within the appropriate time limit
  using the online form available File a Protest
- 17.3 The protest time limit is 60 minutes after the last boat has finished the last race of the day or after flag AP over A is displayed ashore.
- 17.4 A <u>Hearing Schedule</u> will be posted on the Official Notice Board as soon as possible after a protest has been lodged, but not later than 30 minutes after the end of Protest Time to inform competitors of hearings in which they are parties or named as witnesses. Protests will be heard in the order specified on the Hearing Schedule. Parties and witnesses are required to be available via video at the time stated on the Hearing Schedule.
- 17.5 Notices of protests by the race committee or protest committee will be posted to inform boats under RRS 61.1(b) hearings.
- 17.6 On the last scheduled day of racing, a request for redress based on a PC decision shall be delivered no later than 20 minutes after the decision was posted. This changes RRS 62.2.

#### 18 SCORING

- 18.1 As per NOR 15
- 18.2 A competitor may submit a request to review a boat's score online at scoring queries

# 19 SAFETY REGULATIONS [DP]

- 19.1 A boat that retires from a race shall notify the Race committee signal vessel as soon as possible. A declaration form is available online which must be completed by competitors when ashore through this link Penalty Reports
- 19.2 A safety tally system will be in operation.
  - 19.2.1 The tally control point will be at the Tally Hut, a hut displaying the "Tally" flag, adjacent to the main slipway.
  - 19.2.2 Competitors shall individually tally-out before racing by personally going to the tally control point and taking their tally to advise they are going racing.
  - 19.2.3 Competitors shall individually tally-in immediately on returning to shore by personally going to the tally control point and returning their tally to advise they are ashore. This must be done no later than 10 minutes after the last boat has come ashore.
  - 19.2.4 Any competitor unable to return their tally in the time stated in 19.2.3 should take all reasonable steps to contact Parkstone Yacht Club without delay.
  - 19.2.5 The penalty for failing to tally-out or tally-in as instructed above will be five points added to the boat's series score non excludable for each offence. This changes RRS 63.1 and A5.
- 19.3 RRS 40.1 always applies on the water.
- Boats wishing to sail ashore before the end of the day's racing shall not do so unless authorised by an official boat. The official boat will instruct boats in the procedure for returning ashore.
- 19.5 Boats shall follow the instructions of the official boats. Infringements will be reported to the race committee, which may protest the boat. [DP]

# 20 REPLACEMENT OF CREW OR EQUIPMENT

- 20.1 Equipment protests will only be accepted from the technical committee, race committee or jury. This changes RRS 60.1(a).
- 20.2 Requests for substitution of equipment shall be made to the committee at the first reasonable opportunity.

  A Competitor may submit a request online at <u>Equipment substitution</u>





# 21 EQUIPMENT AND MEASUREMENT CHECKS.

A boat or equipment may be inspected at any time for compliance with the class rules and sailing instructions. On the water or ashore, a boat can be instructed by an equipment inspector to proceed immediately to a designated area for inspection. A boat shall comply with any reasonable request made by an Equipment Inspector. [DP]

- 23.1 Official vessels are defined as Race committee signal vessels, Mark Layers, Safety Boats.
- 23.2 Safety boats may carry competitors drinks, snacks, or spares, at the discretion of the driver/crew of the safety boat. Do not leave any bags on the committee or finish boat

26.1 Boats shall be kept in their assigned places whilst in the boat park.


