## **PROCEDURAL MATTERS**

1. The panel of the International Jury was composed in accordance with RRS N1.4(b).

2. Hearing No. 33 was heard together with Hearing No. 34 in accordance with RRS 63.2 since both hearings arose from the same incident.

# **FACTS FOUND**

- 1. The wind was 10-14 knots with flat water.
- 2. FRA 34 and AUT 51 were foiling as they were approaching the start line on starboard tack.
- 3. FRA 34 was overlapped approximately 2m to windward of AUT 51.
- 4. Approximately 8 to 10 seconds before the starting signal there was contact between the kites of FRA 34 and AUT 51.
- 5. The kites remained in contact for 1 to 2 seconds and then released.
- 6. Both kiteboards started the race on time, and finished the race.
- 7. There was no tangle, damage or injury.
- 8. Neither kiteboard took a penalty.

## **CONCLUSIONS AND RULES THAT APPLY**

Rules: RRS 11, 14, F4.43.1(c), 63.2 and N1.4(b).

- 1. FRA 34 to windward did not keep clear of AUT 51 to leeward, breaking RRS 11.
- 2. FRA 34 did not avoid contact when it was reasonably possible, and broke RRS 14.
- 3. AUT 51, the right-of-way boat did not act to avoid contact when it became clear that FRA 34 was not keeping clear. AUT 51 broke RRS 14.
- 4. Since AUT 51 was right-of-way kiteboard and the contact did not cause damage, injury or tangle, she is exonerated under RRS F4.43.1(c) for breaking RRS 14.
