PROCEDURAL MATTERS

1. Protest returned from arbitration for a hearing. The arbitrator decided that arbitration is not appropriate.

- 2. Hearing No. 1 was heard together with Hearing No. 2 in accordance with RRS 63.2 since both hearings arose from the same incident.
- 3. GBR 625 was represented by Tim Wilkins.
- 4. ITA 1604 was represented by Iacopo Roncuzzi.
- 5. The hearing was heard with a panel of three members in accordance with RRS N1.4.
- 6. Holger Herburger, chairman of the panel, had to leave the panel during the hearing because of an emergency and was substituted by David Battye.

FACTS FOUND

- 1. Wind conditions were 11 knots, slight sea state.
- 2. GBR 625 was on starboard tack sailing on a close hauled course 4 lengths below the starting line.
- 3. ITA 1604 was on starboard tack, 2 lengths from the starting line sailing below a close hauled course and overlapped to windward of GBR 625.
- 4. The boats were on converging courses.
- 5. 15 seconds later contact occurred between the forestay of GBR 625 and the boom of ITA 1604.
- 6. Both boats remained entangled for 10 seconds and the starboard side of ITA 1604's boom sustained minor scratches.
- 7. Neither boat took a penalty.
- 8. Both boats finished the race.

CONCLUSIONS AND RULES THAT APPLY

Rules: RRS 11, 14

- 1. ITA 1604 to windward failed to keep clear of GBR 625 to leeward, and broke RRS 11.
- 2. ITA 1604 did not avoid contact when it was reasonably possible, and broke RRS 14.
- 3. It was not reasonably possible for GBR 625, the right-of-way boat to avoid contact with ITA 1604 when it was clear that ITA 1604 was not keeping clear. GBR 625 did not break RRS 14.
