FACTS FOUND

- 1. RC posted course #2 for the first race, with heading and distance to windward mark #1, VHF announcement made stating only mark #1 would be placed, along with heading and distance to Mark 1.
- 2. The J70 fleet started first.
- 3. At mark 3 for the J70 fleet, the RC signaled a mark change to mark #1.
- 4. Six Viper 640s sailed to the J70 orange change mark, but otherwise sailed the course correctly.
- 5. At mark 3 for the Vipers the RC signaled a change to mark #1 to orange.
