



SUPPORT TEAM REGULATIONS

1. General

- 1.1. These Support Team Regulations shall apply at all times while support persons are at the venue or on the field of play.
- 1.2. For the purposes of these regulations, a coach boat includes any boat that is under the control or direction of a person who is or may provide physical or advisory support to an athlete, including the gathering of data that may be used at a later time.
- 1.3. The Organizing Authority may inspect boats at any time to ensure that they comply with these regulations, and the person responsible for the boat shall facilitate such inspection.
- 1.4. An alleged breach of any of these regulations may be referred to the Protest Committee for a hearing. As a result of the hearing the Protest Committee may take action under RRS 64.4 or exclude the person from the event or venue or remove any privileges or benefits for a specified period or for the remainder of the competition. Note also, action may be taken under RRS 69.2.
- 1.5. The Organizing Authority may change these regulations at any time. Any changes will be posted on the Official Notice Board.
- 1.6. The Organizing Authority may, at its discretion, refuse to register coach boats not deemed to be suitable. Generally, open boats more than 4.0m and less than 7.5m in length and having minimal or no superstructure (cabin, coach house, bridge, etc.) are considered suitable.
- 1.7. All support persons shall be register with the Organizing Authority on the day before the first race. Coach boats and designated drivers shall be registered with the Organizing Authority either before leaving the venue by water for the first time or by 18:00 on the day before the first race of the Event that it is supporting, whichever is earlier.
- 1.7.1. Each boat shall be insured with valid third-party liability insurance with a minimum coverage of € 500,000 (or equivalent) per incident or as specified in the NoR/SI.
- 1.7.2. Only accredited persons may be designated drivers.
- 1.7.3. The person registering the coach boat shall confirm that:
 - a) a valid insurance certificate showing proof of third-party liability coverage as required by 1.7.1 has been obtained;
 - b) each designated driver has a motorboat driving license recognized by a national authority appropriate to that boat.
- 1.8. Coach boats shall be marked with the applicable national sail letters (RRS G1.1) clearly displayed in strongly contrasting colours at all times while afloat.

2. Regatta Venue

- 2.1. Coach boats shall use the designated slipway/area for launching. Once launched, trailers shall be moved immediately to the trailer park or as otherwise directed by the Organizing Authority.
- 2.2. Only registered coach boats will be allowed into the regatta venue.
- 2.3. When not in use, coach boats shall be appropriately berthed at the regatta venue in the allocated areas for coach boats for the entire time that these STR apply.

3. Safety

- 3.1. Coach boats shall carry on board:
 - a) life jackets / buoyancy aid for all passengers and the driver;
 - b) first-aid kit;
 - c) VHF radio;
 - d) device for making a sound signal;
 - e) compass;
 - f) adequate anchor and tackle for conditions and depth;
 - g) tow rope (minimum 15m long and 10mm thick);
 - h) operational engine kill cord (also known as a safety lanyard or automatic engine immobiliser);
 - i) hand pump or bailer;
 - j) knife; and
 - k) any additional safety equipment required by local maritime law.
- 3.2. The maximum plated / certified passenger limits for the boat shall never exceed.
- 3.3. Team leaders are responsible for overseeing the safe operation of their coach boats on the water, including knowledge of who is afloat and ensuring their safe return to the venue.
- 3.4. At all times, support persons including the registered driver(s) of a coach boat shall comply with directions given by or under the authority of a Race Official. This includes assisting in rescue operations when requested to do so.
- 3.5. Coach boats shall comply with local harbour and marina regulations, including speed limits.

4. General Restrictions

- 4.1. The registered driver(s) of a coach boat will be responsible for the control of the boat at all times and will be held responsible for any inappropriate behaviour, dangerous actions or improper practices, or actions affecting the fairness or safety of competition.
- 4.2. Support staff shall not leave any device, piece of equipment, buoy, marker or similar item permanently in the water. Temporary use of floating objects is allowed for current measurement. These objects shall be removed as soon as the measurement has been taken.
- 4.3. Coach boats shall take particular care to minimize their wash when transiting the course areas.

5. Support Boat Restricted Areas

- 5.1. The race committee may set support boat marks. If set, support boats shall remain on the non-course side of the support boat marks, wherever they are set.
- 5.2. After the first warning signal of the day, support boats shall move to the support boat zone, if defined, until all racing has been completed, postponed or abandoned for that course area, unless instructed to do otherwise by the Race Committee.
- 5.3. If the Race Committee instructs a support boat to leave the support boat zone, the support boat shall restrict their speed to five knots, keep clear of all official boats and kiteboards, and avoid any propeller wash in areas where kiteboards may be racing.
- 5.4. Between sequences of racing, or when all racing for that course area has been postponed or abandoned, support boats may enter the course area but shall restrict their speed to five knots. If further racing is to take place, support boats shall then comply with the applicable STR.

6. Special Support Boat Rules

- 6.1. For safety reasons, the Race Committee signal boat may display flag V to signal that STR 6 applies.
- 6.2. From the time of the preparatory signal for the first fleet to start until all boats have finished or retired or the Race Committee signals a postponement, general recall or abandonment, support boats shall stay outside areas where kiteboards may be racing. Such areas are defined as:
 - Not closer than 150m to any kiteboard racing (except a kiteboard in distress or requiring assistance);
 - Within 150m to leeward of the starting line, marks and extensions, from the time of the preparatory signal until all kiteboards have left the starting area or the Race Committee signals a postponement, general recall or abandonment;
 - Between any kiteboard racing and the next mark of the course;
 - Between the inner and outer trapezoid courses when kiteboards are racing on both courses:
 - Within 150m of any mark of the course while kiteboards are in the vicinity of that mark; and
 - Within 100m of the finishing line and marks while kiteboards are finishing.
- 6.3. The VHF radio permitted in regulation 3.1 shall be switched on and used for safety communication on the Race Committee VHF radio channel
- 6.4. Support boats shall proceed around the racing area in such a way to minimize the effect their propeller wash will have on kiteboards racing. Except in an emergency, they shall restrict their speed to 5 knots.
- 6.5. Between sequences of races, following a general recall or when all racing for that Course Area has been postponed or abandoned, support boats may enter the Course Area but shall restrict their speed to five knots. If further racing is to take place, support boats shall then comply with the applicable STR.
