## **PROCEDURAL MATTERS**

## **FACTS FOUND**

- 1. Wind 13 knots
- 2. Sea state was moderate chop
- 3. Current was less than 1/2 knot
- 4. Fox was approaching the windward mark on starboard at approximately 9 kts on layline.
- 5. Bad Pak was approaching on port at approximately 9 kts below the port lay line
- 6. Bad Pak tacked from port to starboard to leeward and ahead of Fox, passing head to wind at approximately 4 boat lengths from the mark, and was fetching the mark upon completion of her tack.
- 7. Bad Pak's speed after completing her tack decreased to approximately 6 knots.
- 8. Shortly after Bad Pak completed her tack Fox moving faster became overlapped to windward of Bad Pak
- 9. As Bad Pak came close to the mark she altered course slightly to windward to round the mark.
- 10. Fox altered course to avoid contact with Bad Pak
- 11. There was no contact

## **CONCLUSIONS AND RULES THAT APPLY**

- 1. Bad Pak tacked from port to starboard and kept clear of Fox during the tack; therefore, did not break rule 13
- 2. After completing her tack to starboard Bad Pak gave Fox room to keep clear; therefore, did not break rule 15
- 3. Fox kept clear under rule 11
- 4. Rule 18.3 did not apply because Bad Pak crossed head to wind outside the Zone.
- 5. Bad Pak was entitled to mark-room under Rule 18.2(b)
- 6. Fox gave Bad Pak mark-room required by Rule 18.2(b)
