



NOTICE OF RACE

SB20 Portuguese National Championship

The **Federação Portuguesa de Vela** and the **Club Naval de Cascais** establish this Notice of Race for the realization of **SB20 Portuguese National Championship**, with the support of the **SB20 Portuguese Class**, that will be held from the **17th to the 19th July 2020** at the venue of **Cascais**.

The Standard Sailing Instructions published by the FPV Race Officials Committee will be applied and during the event they shall be posted on the Official Notice Board.

1. RULES

The event will be governed by the “rules” as defined in The *Racing Rules of Sailing*.

2. ELEGIBILITY AND ENTRY

- 2.1. The event is open to boats of the **SB20 Class**;
- 2.2. The eligible participants may sign up filling in the attached Entry Form and sending it together with the registration fee to regatas@cncascais.com up to **18:00** of **July 15th**;
- 2.3. The Organizing Authority reserves the right to accept or not entry registrations out of time, and in case of acceptance, the registration fee maybe increased by **50%**;
- 2.4. The deadlines for registration referred to in the previous numbers, shall not be less than **48 hours** before the start of the first race of the event (Article 6.4, FPV Sporting Regulations);
- 2.5. Competitors must personally confirm their registration by proving their sporting licenses, valid for the current year at the **Race Office** of the event, that will be placed at **CNC Reception**.

3. REGISTRATION FEES

- 3.1. The following registration fee is required: **200€**.

4. PROGRAMA

4.2. Number of scheduled races: **9 (nine)**;

4.3. On the last scheduled day of racing no warning signal will be made after **15:30**;

4.4. 1 (one) race is required to be completed to constitute a series.

5. MEASUREMENT

Each boat shall produce a valid measurement certificate. Besides that, inspections may occur at any time by an official measurer, to comply with the Class Rules and Sailing Instructions.

6. SAILING INSTRUCTIONS

The **Standard Sailing Instructions** published by the FPV Race Officials Committee will be applied and during the event they shall be posted on the **Official Notice Board**.

The **Sailing Instructions Supplement** will be available from **14:00** of the **July 16th** at **Race Office**.

7. SUPPORT BOATS

Support persons boats should register at the **Race Office** and will have to use mandatorily the identification required in the Sailing Instructions.

8. RADIO COMMUNICATIONS

A boat that is racing shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats. This restriction it also applies to mobile phones.

9. PRIZES

Prizes will be given to the **top 3 boats, overall**.

10. DISCLAIMER OF LIABILITY

The competitors participate in the regatta entirely at their own risk. See RRS 4 - Decision to Race. The Organizing Authority will not accept any liability for material damage, personal injury or death, sustained in conjunction with or prior to, during or after the regatta.

11. INSURANCE

Each participating boat shall be insured with valid third party liability insurance with a cover amount appropriate to the activity.

12. SPECIFIC RULES

The minimum number of participating boats (boats that start at least in one race) is:

- **10 (ten)** to National Championships.
