PROCEDURAL MATTERS

FACTS FOUND

9-11 knots of wind, relatively flat water, incident at 6.5-7 knots of boat speed, there was current at about 1.25 knots.

With Grace was on starboard, following Lodos (J109) into the weather mark.

Dangerous When Wet was on port.

With Grace was slightly to weather and clearly astern Lodos.

With Grace had eased their genoa and the trimmer remained on the port side. The driver was steering from the port side.

Dangerous When Wet, ducked **Lodos**, then turned back up to cross **With Grace** who had not yet extended their pole, but was in the process of doing so.

While crossing **With Grace**'s bow, **Dangerous When Wet saw** the pole (7') extended on **With Grace** and attempted to tack short to minimize contact, however as soon as the tack was initiated, the impaled sprit prevented it.

With Grace did not alter course from the time she first saw Dangerous When Wet until the impact.

With Grace's pole crossed the deck under the lifelines approximately 3' ahead of **Dangerous When Wet**'s stern and became entrapped in the stern pulpit. Subsequent motion brought the hulls together, further entangling the boats.

Both boats substained significant damage and retired from Race 5. No injuries were reported.

CONCLUSIONS AND RULES THAT APPLY

Dangerous When Wet failed to keep clear of With Grace, the starboard tack boat, breaking rule 10.

With Grace, right of way boat, failed to avoid contact when it became clear the Dangerous When Wet was not keeping clear, breaking rule 14.
