PROCEDURAL MATTERS

Part 2 incident and subject to arbitration under WCR App T, SI 18.1

1.Arbitration is scheduled for 0930H on 9Feb and then followed by a redress hearing thereafter if requested.

- 1. Arbitrator assigned: Tan Tee Suan IJ SGP heard at 0930H.
- 2. Protest hail heard
- 3. Informed RC at finish
- 4. Protest lodged in time
- 5. No damage or injury
- 6. No board carried out any 360 penalty.
- 7. THA26 accepted a post race penalty
- 8. INA3 allowed to withdraw her protest.

FACTS FOUND

- 1. THA26 close hauled on port was converging with INA3 close hauled on starboard when approaching M1 in leg 3 of Race 9
- 2. THA26 collided with INA3 resulting in INA3 capsizing.
- 3. THA26 continued to sail without carrying out a 360 degree penalty
- 4. There was no damage or injury
- 5. THA26 finished 1st and INA3 finished 2nd in Race 9

CONCLUSIONS AND RULES THAT APPLY

- 1. THA26 on port failed to keep clear of INA3 on starboard, and broke RRS 10
- 2. THA26 did not avoid contact when it was reasonably possible, and broke RRS 14.
- 3. INA3 who capsized is entitled to redress under WCR 62.1(b)

1. THA26 accepted that she broke RRS10 and 14 and to have a post race penalty of 30% added to her score in Race 9 in accordance with App T1 (b) [30% of 6 boards = 1.8, =2 after rounding up to the next whole number =1+2= 3 in race 9]
