PROCEDURAL MATTERS

1. US 14 was not present at the time of the first hearing on July 14, 2019. The hearing proceeded under RRS 63.3(b).

- 2. On July 14 and July 15, 2019, a protest filing was displayed in error on the website that displayed scores for the event. This error by the PC caused confusion, and as a result the PC decided to reopen the hearing on July 20, 2019.
- 3. USA 60820 was unable to attend the reopening and chose not to send a representative.
- 4. USA 14 provided tracking and video evidence at the reopening.

FACTS FOUND

- 1. 14 knots of wind.
- 2. USA 60820, a 30' Cruising Boat was sailing in the PHRF Non-Spinnaker Class.
- 3. USA 60522 Oh Jee!!, a J 88 was sailing in PHRF Division I, preparing to start her race #3.
- 4. USA 14, a J 92 was sailing in the PHRF Division II, preparing to start her race #3.
- 5. The PHRF Non-spinnaker Class had a single race, sailing the Navigators Course #75.
- 6. USA 60820, was approaching the finish on a broad reach on starboard tack.
- When USA 60820 was approximately 3 boatlengths from the finish line, USA 60522 approached on port tack and her starboard side passed to windward of the starboard side of USA 60820
- 8. USA 60522 tacked from a broad reach back to a broad reach and approached the windward side of USA 60820 on port tack on a converging course.
- 9. USA 60820, to leeward, hailed USA 60522 to windward.
- 10. No collision occurred.
- 11. USA 60820 hailed the RC on the VHF that she intended to protest Oh Jee!!
- 12. The RC recorded USA 60820 protesting USA 60522.
- 13. USA 60820 submitted a protest form indicating that she was protesting USA 14.

- 1. USA 14 was mis-identified as the protested boat on the protest form that was filed.
- 2. The protested boat may be identified at any time before the hearing per RRS 61.2, but not during the hearing.
