PROCEDURAL MATTERS

GER 3 not present - hearing continued under RRS 63.3(b).

FACTS FOUND

- 1. Wind 15 kn, waves 0,5 m.
- 2. Board BEL 113 was sailing close-hauled on starboard tack on collision course with board GER 3 sailing close-hauled on port tack.
- 3. GER 3 hold his course
- 4. At distance of 2,5 board lenghts from GER 3, BEL 113 bore away in order to avoid the collision.
- 5. There was a contact with serious damage between BEL 113 board's bow and GER 3 board's starboard side behind the daggerboard.
- 6. Both boards capsized.
- 7. There was no injury.
- 8. Both boards finished the race No. 3.

CONCLUSIONS AND RULES THAT APPLY

- 1. GER 3 on port failed to keep clear of BEL 113 on starboard, as required by RRS 10.
- 2. It was reasonably possible for GER 3, the keep clear board, to avoid contact with BEL 113, however he failed to do so, breaking RRS 14.
- 3. It was not reasonably possible for BEL 113, the right-of-way board, to avoid contact with GER 3 when it was clear that GER 3 was not keeping clear, therefore she did not break RRS 14.
- 4. Because of the physical damage and capsize caused by GER 3 breaking a rule of Part 2, BEL 113's score was made significantly worse through no fault of her own.

Date & Time: 2019-05-14 17:00 CEST

- 1. GER 3 is disqualified in race 3.
- 2. Redress is given to BEL 113. BEL 113 is to be scored in race 3 points equal to the average, rounded to the nearest tenth of a point (0.05 to be rounded upward), of her points in races 1 and 2. This shall not be worse than BEL 113's finishing position in race 3 and shall not change the score of the other boats.
