PROCEDURAL MATTERS

FACTS FOUND

- 1. Cases 7 to 13 were decided and USA 1464, USA 1427, AUS 1332, AUS 870, AUS 1444, AUS 1374, AUS 1287, were informed of the decision on 26th Oct 2018, 2135h (GMT+10).
- 2. The International Jury received a request to reopen Cases 7 and 8 from USA 1464 and USA 1427 on 27th Oct 2018, 0730h.
- 3. USA 1464 and USA 1427 requested to have the hearing to request for reopening of Cases 7 and 8 prior to racing on 27th Oct 2018.
- 4. The International Jury scheduled and heard the request for reopening hearing at 0830h on 27th Oct 2018.
- 5. The tracker data for Race 8 on 26th Oct 2018 was freely available for public viewing on the event website or on a large television screen in the Regatta Office and the data was available before the time of the hearing of Cases 7 to 13.
- 6. The tracker data displayed the Groundspeed of the boats which were affected by light winds and a strong current of about 1-2 knots. Therefore, the tracking data is not indicative of the speed through the water.
- 7. The event Race Management Policies stated at the top of the document on Page 1 that the policies were guidelines to the Race Management Team and that "failure to observe these guidelines are not grounds for redress."
- 8. The event Race Management Policies are not listed under Rules in NoR 2 or SI 1 or *rules* as per the definition of *rule* in the Racing Rules of Sailing (RRS).
- 9. The Facts Found for Cases 7 to 13 did not mention that the fleet inverted or that the wind speed dropped below 3 to 4 knots.
- 10. The Race Committee consecutively (1) decreased the length of Leg 3; (2) shortened the course and; (3) abandoned the race.
