## **FACTS FOUND**

- 1-The incedent occured on the 4th race of the 21/Jul/2022
- 2-During the incident, AUT was injured and was taken to the shore with a RIB of the OA. She received medical assistances in term of some stitches in one of her feet.
- 3-On the 22/Jul/2022 at 12.00hs AUT 74 unsuccesfully searched for the Jury to ask if she should could lodge a protest&request for redress.
- 4-The protest was lodged on the online platform on the 22/jul/2022 at 15:57

## **CONCLUSIONS AND RULES THAT APPLY**

Rules: 61.3, 62.2

AUT 74 failed to deliver the protest & request for redress within the protest time limit, as required by RRS 61.3 and 62.2. There was good reason for the PC to extend the time limit under RRS 61.3 and 62.2. since AUT 74 had to be taken to the shore and had to receive medical assistance. However, AUT 74 lodged the protest & request for reddress well beyond the first reasonably opportunity to do so.
