## **PROCEDURAL MATTERS**

1. Diogo Cayolla attended the hearing representing Scugnizza.

- 2. Anja Eckart, photographer, attended the hearing as witness called by Scugnizza.
- 3. Nico Martinez, photographer, attended the hearing as witness called by Scugnizza.

#### **FACTS FOUND**

- 1. Scugnizza asked some photographers for pictures this morning at 07:30 and received them at 07:45.
- 2. Scugnizza presented a photo from yesterday showing that Santina kept her red flag rolled up on the starboard pushpit.
- 3. Scugnizza presented some pictures showing Santina rounding mark 1 (time of the pictures: around 15:41); in these pictures, the starboard pushpit is not visible and no red flag is visible on the port pushpit or on the backstay.
- 4. Scugnizza presented a picture of Santina sailing on the first downwind of that race (time of the picture 15:44:42); in this picture, the starboard pushpit is visible with the event flag flying. However, the red flag is not visible at all (neither open, nor wrapped) due to the low quality of that part of the image, being off the camera main focusing point.
- 5. Scugnizza presented a picture of Santina taken today showing that the red flag was open.

# **CONCLUSIONS AND RULES THAT APPLY**

Rules: RRS 66.1

The evidence that Scugnizza plans to present could have been available at the time of the original hearing, had they
asked it at that moment. Furthermore, the photo is not proving that the flag has not been displayed. The evidence that
Scugnizza plans to present is not new. Therefore, the requirements in RRS 66.1 for reopening the hearing are not
met.
