NOTICE OF RACE: 12th Monsoon Regatta – 2021



1. EVENT & VENUE:

1.1 The shore venue is The Yacht Club of Hyderabad, Sanjivaiah Park, Hussain Sagar, Hyderabad, INDIA

1.2 The Regatta will consist of 3 Championships to be sailed between July 19 to July 26 subject to changes based on the Covid situation.

- a) Monsoon Regatta Optimist Championship – National Ranking
- b) Monsoon Regatta Optimist Green Fleet
- c) Monsoon Regatta Optimist Light Fleet (Half Rig)
- d) Monsoon Regatta Optimist Team Championships
- e) Monsoon Regatta Laser 4.7 Championships

2. ORGANISING AUTHORITY:

The Monsoon Regatta will be hosted by the Yacht Club of Hyderabad (OA- Organizing Authority) under the aegis of the Telangana Sailing Association, respective Class Associations and The Yachting Association of India.

3. RULES:

The Championship will be governed by:

- 3.1 The Rules as defined in the Racing Rules of Sailing (RRS) 2021-2024

- 3.2 RRS Appendix P, Special Procedures for Rule 42 will apply.
- 3.3 [SP] denotes a rule for which a standard penalty may be applied by the Race Committee or Technical Committee without a hearing (this changes RRS A5.1).
- 3.4 [NP] denotes a rule that shall not be grounds for protest by a boat and for which the International Jury may refuse to hold a hearing. This changes RRS 60.1(a) and 63.1.
- 3.5 English shall be the official language of the championship. Participants will be allowed their own interpreters.



4. ADVERTISING:

4.1 The Event is designated as Category C. All competitors will be required to display advertising of the event sponsors on each side of the hull in accordance with the RRS for the Main Optimist Fleet but restricted by Class Rule 2.8.

4.2 All other classes including the Green Fleet will wear sponsor logos on hulls and sails and clothing bibs or T shirts if provided by the sponsor. No Team sponsor will be allowed display space on boats or garments/clothing without the prior written permission of the OA Monsoon Regatta.

4.3 [SP] Boats carrying sponsor logos from previous championships will need to remove all such insignia prior to arrival at the venue. Boats carrying messages of sponsors not authorized by the organizers will be penalized **3 points per race** subject to the confirmation of the Protest Committee.

4.4 MEDIA, IMAGES AND SOUND

The OA shall have the right to use any images and sound recorded during before or after the event across classes and championships and regattas free of any charge for all classes and the YCH will own all copyrights to all footage and photographs produced at the event and is free to publish or sell or grant rights to any third party for the said images and photographs and footage. Participants by virtue of their participating and all support personnel either on shore or offshore absolve themselves of any rights to any images, still or moving and any sound bytes or image bytes recorded by the organizers and their vendors or representatives. No club, boat owner, city or participant can film/record the proceedings for commercial purposes or public broadcast without the prior permission of the OA in writing. Boats may be required to carry cameras and sound equipment, or positioning equipment specified by the OA.



5. ELIGIBILITY & ENTRY:

- 5.1 Open to all members of clubs affiliated/registered with YAI and the respective Class Associations and whose subscription/dues are fully paid up where necessary. The Green Fleet sailors are exempt. All participants must have a valid YAI membership Card and a World Sailing Membership in the Main Optimist Fleet.
- 5.2 All Optimist sailors must be born on or after 1st Jan 2005. Valid, parent attested Proof of Age is to be provided at the time of Registration for all fleets. Laser 4.7 sailors shall be under 18 yrs (the age the competitor becomes in the year [of the championship](#)).
- 5.3 Eligible competitors may enter by completing the attached form and sending it together with the entry fees payable by bank transfer favoring

- 5.4 Late entries will be accepted on payment of an additional Late Fee of Rs.1000/-, [unless](#) waived by the organizers
- 5.5 Last date of entry will be one week before the commencement of Championship; however the competitors who wish to make the payment upon arrival in Hyderabad may confirm entries with all details by email to Secretary@yachtclub.in and they will not face any levy of late fee provided all entries committed by the club pay.

All girls will be provided with 50% discount on Entry fees.

Practice and launching of club support boats will be allowed only after registration and payment of all fees including the practice fee.

A few top quality Optimist hulls spars and foils (No sails or lines) will be available on charter on a first paid first served basis. No damage deposit will be required from those who carry their own boats. Coach Boats and Coach registration fees shall be Rs.7500/- each

The Green Fleet and Light Fleet sailors can use any Training Optimist. IODA certified Optis are also eligible. The Green Fleet is meant only for sailors with no prior regatta experience.

- 5.7 All competitors in the Optimist Class Main Fleet shall comply with the World Sailing eligibility required in accordance with WS Regulation 19 and be members of the YAI prior to registration. Does not apply to Green & Light Fleet sailors.
- 5.8 Teams for the Team Racing shall comprise of 4 boats and the format will be presented in the Sailing Instructions

6. CONDITIONS OF ENTRY:

- 6.1 Competitors must be capable of swimming at least 50 meters without buoyancy aids. Satisfaction of this clause is assumed by virtue of participation and the responsibility of compliance of this clause is the responsibility of the participant and the respective club's signatory and that of the parent/guardian.
- 6.2. [NP] Those helms/crew judged as not competent to race under the conditions prevailing may be sent back to shore and / or not permitted to race and will be sent ashore by the Race Committee.
- 6.3 Each Club will send one adult, designated as **Team Leader** in writing, on the entry form, to serve as a single point of communication to the team/club across all classes with the OA. The team leader will also serve as the guardian for all minors in the team and will need an authorization letter signed by the parent and the respective club Commodore confirming the same.

8. SAILING INSTRUCTIONS:

The sailing instructions, when ready will be available on final registration at the Venue or online at www.theyachtclub.in

9. COURSE The Courses are as described in ANNEXURE 1

10. SCORING The low point scoring system RRS – “Appendix A” will apply for Fleet racing . For Scoring in Team Racing RRS D3 will be in force. There will be only one discard applicable and the SI will elaborate on the scoring system

11. MEASUREMENT

- 11.1 All IODA Optimists and Lasers shall produce a valid Registration Book and Sail Measurement Certificate. To be enclosed with the Entry form. Measurements validated for the Telangana State Regatta will be valid for the Monsoon Regatta. Not applicable to Light and Green Fleet Boats.
- 11.2 The Technical Committee or it's appointed representative reserves the right to check/measure the racing equipment and eligibility of sailor at any time during the Championship.

12. BOATS:

- 12.1 The Optimist event will be conducted in the International Optimist Dinghy. Competitors are required to bring their own boats and equipment for the championship. Few boats may be available for charter in an as-is-where-is condition, subject to prior request and payment of Charter and damage deposit All payable in advance.
- 12.2 For the Green Fleet, boats will be provided by the OA on a first come first served basis at a charter fee of Rs.12000/- only and a Damage deposit of Rs.15000/- (No exemption and payable in cash only.) Competitors may bring their own boats.
- 12.3 Damage Deposit
 - (a) The initial damage deposit shall be paid at registration in cash or DD only.
 - (b) In the event of a deduction from the damage deposit is decided by the OA it will require that the deposit be restored to its original amount before the skipper will be permitted to continue in the event.
- 12.4 Substitution of damaged equipment may be permitted after the Measurer/OA has provided the Race Committee with approval in writing prior to the race being sailed with the substituted equipment. Rules for Emergency substitution on water and in-between races may be provided for in the Sailing Instructions.
- 12.5 Competitors are allowed to use only one hull, dagger board, rudder (with tiller

extension), mast, boom, sprit, and sail during the Championship. These parts of the Equipment may be measured at random according to the measurement regulations and approved to be complying with the relevant Class Rules.

13. PENALTY SYSTEM:

13.1 **The decisions of the International jury will be final as provided in RRS 70.5.**

14. PRIZES and AWARDS:

Optimist Championship and Green Fleet

- a) Overall Winner Trophy Main Fleet
- b) Gold Silver and Bronze medals for the overall 1, 2 and 3rdpositions in Boys Main Fleet
- c) Gold Silver and Bronze medals for Girls 1, 2 and 3rdpositions in Girls Main Fleet
- d) Gold Silver and Bronze medals Boys & Girls separately 1, 2 and 3rdpositions Green Fleet
- e) Gold Silver and Bronze medals for Boys and Girls separately 1, 2 and 3rdpositions in Light Fleet
- f) Trophy for Team Championship Winner
- g) Medals for 1,2,3 positions in the Team Championships
- h) Medals for the 1st 3 positions in the Laser 4.7 Boys and Girls separate

15. INTERNATIONAL JURY

An International Jury will be appointed in accordance with RRS 91(b).

16. SAFETY:

- 16.1 In the Optimist and Green Fleet. each competitor shall carry an 8 Meter tow rope, whistle attached to his/her clothing, a secured paddle with a surface of not less than .25 sq meters.
- 16.2 Competitors shall sign out/sign in, in the register kept with the Beach Master before launching and on coming ashore. This is a mandatory safety requirement.
- 16.3 [SP]A penalty of up to 3 points may be imposed on any competitor not complying with the above safety rules for each race in that day. This changes RRS64.1.
- 16.4 **Personal Buoyancy** All competitors shall bring their own adequate personal buoyancy which must be worn & fastened to their person at all times while afloat. Wet/ dry suits do not constitute adequate personal buoyancy.

SUPPORT VESSELS & COACHES:

[DP] Support Vessels will be marked with large white flag (S) clearly identifying the Club(s) it belongs to. Support vessels interfering with the racing (and the boats they are supporting) in any manner whatsoever will be subjected to a Protest hearing. **After the Preparatory Signal all support vessels will be positioned at the support buoy and not at either end of the start line.** All Coaches need to register @ Rs.6000/Coach. Support Staff can also make the same payment and will be provided with lunch and all other facilities.

18. RADIO COMMUNICATION:

Unless in an emergency a boat racing shall neither make radio transmissions nor receive radio transmission not available to all boats. This instruction applies to mobile phones also.

19. ENTRY DISCLAIMER OF LIABILITY and INSURANCE:

- 19.1 Competitors participate in the regatta entirely at their own risk. See RRS 3, which states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone.". The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with, prior to, during, or after the regatta.

It is the competitor's decision to enter or to start and continue in any race. Competitors shall accept that their participation is at their exclusive risk in every respect. By way of entry competitors shall indemnify the Organizing Authorities, Coordinating Authorities and the respective Host Sailing Club(s), their officers, members, servants and agents in respect to all claims and demands of whatever nature which may be made upon them in connection with or howsoever arising from their participation or intended participation. The Organizing Authorities, the Coordinating Authorities and the respective Host Sailing Club(s), their officers, members, servants and agents accept no responsibility in respect of loss of life, personal injury or loss or damage to property which may be sustained by reason of their participation or intended participation in an Event or howsoever arising in connection with an Event.

- 19.2 All competitors and team and boats shall have third party insurance cover for any accident both life and medical. All competitors who sign the Entry Form are deemed to have made a declaration that they hold such cover as they consider adequate. The organizers will not provide for any compensation for any accident before, during or after the event.



20. Accommodation and Boarding

COVID RESTRICTIONS AND BUBBLE

All participants and officials will need to have an RTPCR Covid test done on arrival at the premises and at their own expense and will be placed in special quarantine till the results arrive. If negative then they will be allowed into the bubble which will be created for the regatta. Those positive will need to return and will not be allowed to participate.

The bubble will be strictly maintained and any sailor or official or parent leaving the bubble will need to quarantine again till they test Covid negative and will have to leave the Regatta in case Covid positive.

Sailors or officials found violating this strict protocol will be disqualified by the OA subject to a Jury hearing in absentia.

The Government prescribed protocol will be maintained by all participants at all times

The Youth Hostel situated on the Hussain Sagar will be the primary location of both quarantine and lodging.

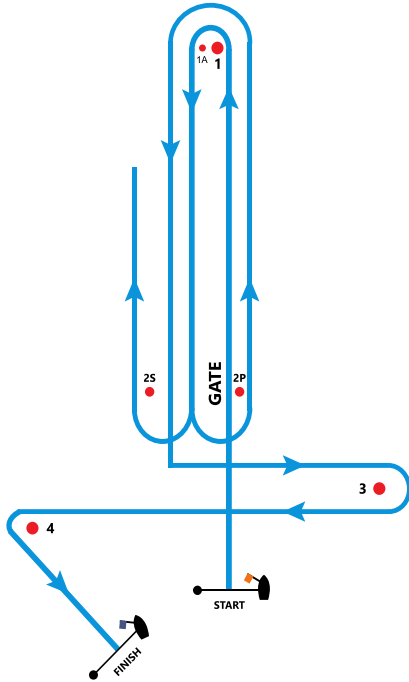
Packed or Buffet lunches will be provided to registered competitors and registered coaches only on all Race Days. All others on a paid booking basis.

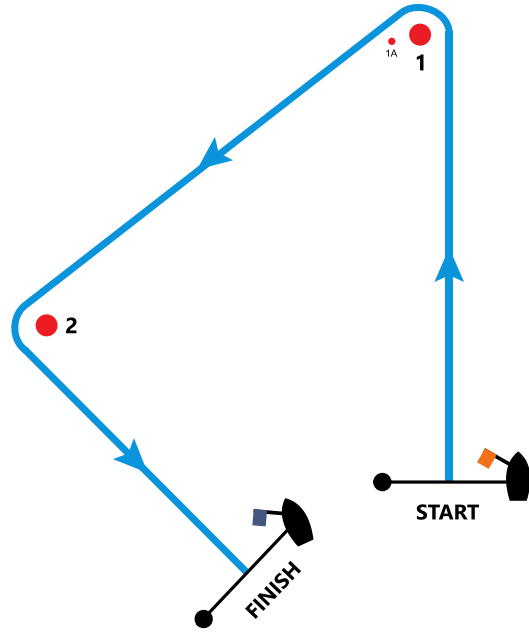

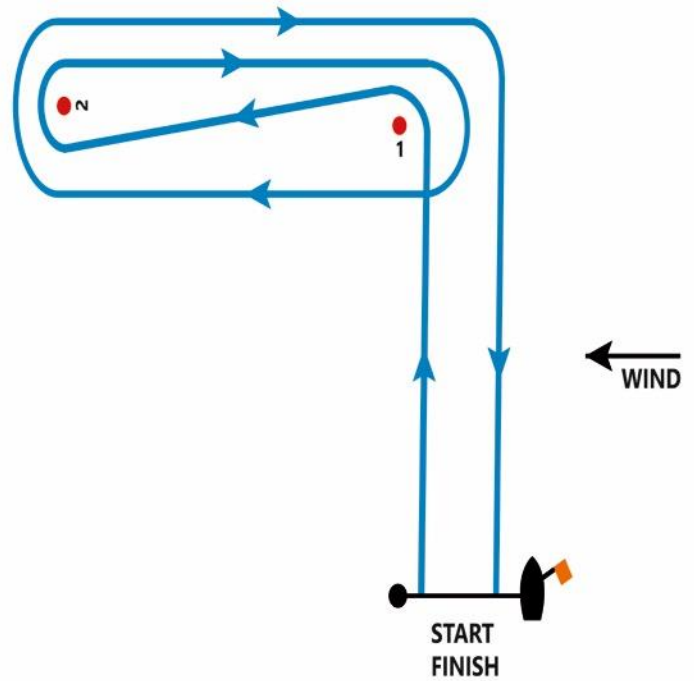
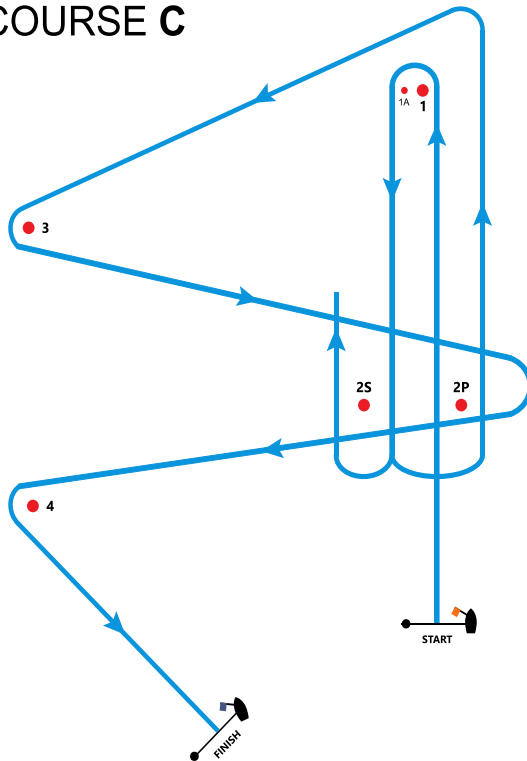
