#### **PROCEDURAL MATTERS**

205264 did not come to the hearing, the hearing proceeded in accordance with RRS 63.3(b). Observers: Chan Wai Kei, Cynthia Law (Spectator), Luke Van Der Kamp (Coach), Chao Wang (Jury)

#### **FACTS FOUND**

- 1. Sea state was slight. Wind was approximately 7 to 10 kts.
- 2. 10 Seconds before the start of race 9, 221400 was on starboard tack. 205264 was on port tack
- 3. Both boats were positioned just below the start line.
- 4. When 205264 tried to pass leeward of 221400, the bow of 205264 made contact with the aft quarter of 221400 and entangled with the mainsheet of 221400 for 20-30 seconds.
- 5. The boats separated without damage.
- 6. Both boat continued and completed the race.
- 7. Neither boat took a penalty turn.

### **CONCLUSIONS AND RULES THAT APPLY**

Rules: RRS10, RRS14

- 1. 205064 on port failed to keep clear of 221400 on starboard, and broke RRS 10
- 2. 205064 did not avoid contact when it was reasonably possible, and broke RRS 14.
- 3. It was not reasonably possible for 221400, the right-of-way boat, to avoid contact with 205064 when it was clear that 205064 was not keeping clear. 221400 did not break RRS 14.
- 4. Because there was no damage or injury on 221400, the requirement for redress in RRS 62.1(b) is not met and redress is not given.

## **DECISION**

205264 is DSQ in race 9.

Redress is not given to 221400.
