PROCEDURAL MATTERS

FACTS FOUND

- 1. ISR 112 and POL 123 were approaching the start line on starboard tack.
- 2. POL 123 overlapped to leeward of ISR 112 with a distance of 8 meters between them.
- 3. POL 123 lifted her kite abruptly.
- 4. There was contact between a tip of the kite of POL 123 and kite of ISR 112.
- 5. ISR 112 and POL 123 capsized.
- 6. The fuselage of ISR 112 got stuck in between lines of POL 123.
- 7. Damage to ISR 112 was a millimeter dent and a three millimeter cut tip of her front wing.
- 8. POL 123 retired from race 6.
- 9. After the incident ISR 112 approached her support boat and decided not to continue.
- 10. ISR 112 started and finished races 7 and 8 using the same equipment.
- 11. ISR 112's scores in races from day 1 were: 6, 3, 1, 3 and from the day 2 were: 3, 5, 4, excluding race 6.

CONCLUSIONS AND RULES THAT APPLY

Rules: RRS 14, 16.1, 62.1

- 1. POL 123 right of way, changed the position of her kite without giving room to ISR 112 to keep clear, breaking rules 16.1 and 14.
- 2. It was not reasonably possible for ISR 112 to avoid contact, therefore she did not break rule 14.
- 3. By retiring, POL 123 took the appropriate penalty for her breach.
- 4. ISR 112's score in race 6 was made significantly worse through her own fault by deciding not to continue racing. Therefore, the requirements for redress in RRS 62.1 are not met.
- 5. ISR 112's score in following races was not made significantly worse by damage. Therefore, the requirements for redress in RRS 62.1 are not met.

DECISION

Redress is not given.
