PROCEDURAL MATTERS

1. ITA 8201 did not come to the hearing, the hearing proceeded in accordance with RRS 63.3(b).

2. NICOLO KRAVANJA, coach of SLO 377, attended a hearing as a observer.

FACTS FOUND

- 1. 4kts wind, flat water.
- 2. MLT 165 clear ahead at the zone of mark 3P.
- 3. SLO 377 to windward and inside overlapped with ITA 8201 to leeward both clear astern of MLT 165.
- 4. Both ITA 8201 and SLO 377 established late inside overlap with MLT 165 and entered the room between mark 3P and MLT 165.
- 5. There was a contact between SLO 377 sail and ITA 8201 back.
- 6. There was a contact between hulls of ITA 8201 and MLT165
- 7. No boat took a penalty turn.
- 8. There was no damage.

CONCLUSIONS AND RULES THAT APPLY

Rules: 18.2(b), 14

- 1. It was not reasonably possible for MLT165, the boat sailing within the mark-room to which she was entitled to avoid contact with ITA 8201when it was clear that ITA 8201 was not giving mark-room. MLT 165 did not break RRS 14.
- 2. ITA 8201 and SLO 377, clear astern at the time MLT 165 reached the zone, failed to give MLT 165 mark-room, and broke RRS 18.2(b).
- 3. ITA 8201 and SLO 377 broke rule 14.
