Organizing Authority (OA): The regatta is hosted by Army Yachting Node (AYN), Mumbai under the aegis of Yachting Association of India (YAI).

1. RULES

- 1.1 The regatta will be governed by the rules as defined in the 2021-2024 Racing Rules of Sailing (RRS).
- 1.2 The Equipment Rules of Sailing and current class rules of the competing classes will apply.
- 1.3 In all rules governing this event, the notations;
 - 1.3.1 [DP] denotes that the penalty for a breach of the rule may, at the discretion of the protest committee, be less than disqualification.
 - 1.3.2 [SP] denotes a rule for which a standard penalty may be applied by the Race Committee or Technical Committee without a hearing or a discretionary penalty applied by the protest committee with a hearing. This changes RRS 63.1, A4 and A5.1
 - 1.3.3 [NP] denotes a rule that shall not be grounds for protests by a boat. This changes RRS 60.1(a) and 63.1.
- 1.4 **Appendix P Special Procedures for Rule 42 will apply.**
- 1.5 **Appendix T Arbitration will apply.**
- 1.6 If there is a conflict between languages, the English text will take precedence.
- 1.7 If there is a conflict between a rule in the Notice of Race and a rule in the Sailing Instructions, the rule in the Sailing Instructions will take precedence. This changes RRS 63.7.
- 1.8 [DP] [NP] All prevailing Central and State Government SOPs and protocols with regards to COVID -19 shall be strictly adhered to by all personnel when ashore. All such instructions will be prominently displayed on the Official Notice Board.

2. ADVERTISING

[DP] Boats may be required to display advertising provided by the OA. If this rule is broken, World Sailing Regulation 20.9.2 applies. Competitor advertising will be restricted to World Sailing Regulation 20, Advertising Code.

3. ELIGIBILITY AND ENTRY

3.1 The event will be held in the following categories: -

3.2 This event is a National Ranking Event as per YAI Policy. A **minimum of five** participating boats in class will be required for the series to be constituted for all the classes, **except 49erFX, RS:X (W), iQFoil(W) and NACRA 17** classes wherein three participating boats in class will be required.

3.3 Eligible boats are to enter by completing the attached **Entry Form** at Addendum 'A' and forwarding the same to AYN email id: aynevent@gmail.com by **15 Dec 2023** along with the details of entry fee paid in the bank account mentioned in para 4.2. Late entries will be accepted only at the discretion of the OA upon payment of additional late fees as given at Para 4.1 below. No withdrawal of entries will be permitted after **21 Dec 2023**.

3.4 All competitors must fill the **Indemnity Bond** provided at the end of this NOR.

3.5 All participants and representing clubs are required to be life members/ annual associate members/ affiliated to YAI. Original membership cards are to be produced at the time of registration, failing which, entries will not be accepted.

3.6 All participants are required to get their own boats for the event. No boats will be provided by the OA.

3.7 Competitors and their support teams shall complete an on-site registration at the Race Office. Each team shall be accompanied by the team leader, who may complete the registration on behalf of the team with all necessary documents. The on-site registration of each competitor will not be complete until the measurement form issued by the Technical Committee has been submitted to the Race Office.

3.8 Each competitor can participate only in one event.

3.9 Competitors under 18 years of age shall provide a signed Consent and Declaration Form. The **Consent and Declaration Form** is placed at Addendum 'B'.

4. ENTRY FEE AND BANK DETAILS

4.1 The entry fee for competitors will be as follows: -

4.3. Entry Fees shall be free of bank commissions. Any bank commission applicable will be charged to the competitors.

4.4 **Concession in Entry Fee for Women Participants.** 50% concession in entry fee is applicable for women participants as mandated by the YAI and this is not applicable in Late Entry Fee and Mix categories of boats.

5. FORMAT

5.1 The regatta will consist of a single series of fleet racing for all events.

5.2 A maximum of **12 races** are scheduled for **Nacra 17 (Mixed), 49er, 49er FX, Formula Kite (M & W), RS:X (M & W), iQ FOiL (M & W)** and **10 races** for 470 (Mixed), ILCA 7, ILCA 6, Optimist and Race board (Open, U-19, U-15, U-13 & Masters) classes.

6. SCHEDULE

6.1 The venue will be open for practice from **09 Jan 2024** onwards. Teams/Trucks must **not** arrive before **1800h** on **08 Jan 2024**. Advance arrival intimation must be given for smooth access.

6.2 Registration and measurement will be scheduled **from 0900 hrs to 1200 hrs on 12 Jan 2024 for Optimist and Race board classes** and on **15 Jan 2024 for all other classes from 0900 hrs to 1200 hrs.**

6.3 The schedule will be as follows:

(a) For Optimist & Race Board (Open, U-19, U-15, U-13 & Masters - Born before 01 Jan 1984).

- 6.4 In fleet racing, not more than three races will be sailed on each day.
- 6.5 For Optimist and Race board classes No warning signal will be made after **1300 hrs on 15 Jan 2024** and for all other remaining classes **1330 hrs on 20 Jan 2024**.
- 6.6 The prize giving ceremony for Optimist and Race board classes is scheduled at **1700 hrs on 15 Jan 2024** and for all other remaining classes **1700 hrs on 20 Jan 2024** at the Venue.

7. MEASUREMENTS

- 7.1 Measurement certificates are required for Optimist & 470 classes of boats.
- 7.2 Only class legal hulls, sails, spars and foils are allowed to be used for the event.
- 7.3 Boats may be subject to inspection at any time during the event.
- 7.4 [DP] Change of damaged or lost equipment will be allowed only after the approval of Technical Committee. Such requests shall be made to the Technical Committee at the first reasonable opportunity by filling of a relevant form kept at the Race Office. The change of equipment may only be permitted after the Technical Committee has checked and scrutinized both the damaged and the substitute equipment.
- 7.5 [DP] If any change of equipment is made on water before or between races, both damaged and equipment substituted shall be presented to the Technical Committee after the end of the day's racing. Repairs or replacements required afloat may be approved after the race provided that either the Race Committee or the Technical Committee afloat is notified before the next race.

8. SAILING INSTRUCTIONS

The Sailing Instructions will be available after completion of registration.

9. VENUE

The venue for the event will be **Girgaon Chowpatty, Marine Drive, Mumbai, Maharashtra 400004**. The racing areas will be off Raj Bhavan/Governors House as placed at Addendum 'C'.

10. COURSES

The courses will be as described in the Sailing Instructions.

11. PENALTY SYSTEM

A Protest Committee will be appointed in accordance with RRS 91 (a).

12. SCORING

- 12.1 RRS B8 is deleted.
- 12.2 Five (05) races are required to be completed in each class to constitute a series.
- 12.3 When fewer than seven races have been completed in the series, a boat's series score will be the total of her race scores.
- 12.4 When seven to ten races have been completed in the series, a boat's series score will be the total of her race scores excluding her worst score.
- 12.5 When eleven or more races have been completed in the series, a boat's series score will be the total of her race scores excluding her two worst scores.

13. [DP] SUPPORT VESSELS

- 13.1 All support vessels are to stay at least 100m outside the racing area from the time of the first preparatory signal for the first class to start till the completion of all races. Support vessels are to maintain a speed of 5 knots or less, unless otherwise required, when races are ongoing.
- 13.2 Support vessels will be marked with their club insignia.
- 13.3 Personnel onboard support vessels are required to wear a life jacket / personal floatation device and carry a functional VHF radio whilst on water and to be a certified Power Boat Handling Certificate holder from YAI.
- 13.4 The engine safety cut out switch and tether (kill chord) shall be securely attached to the driver at all times when the engine is running.

14. [DP] [NP] BERTHING

Boats will be kept in the assigned boat parking places only at the venue.

15. [DP] [NP] RADIO COMMUNICATION

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

16. PRIZES

16.1 Medals in each category will be given as follows:-

- (a) 3 entries - Gold Medal only
- (b) 4-5 entries - Gold and Silver Medal only.
- (c) 6 or more entries - Gold, Silver and Bronze Medal.

16.2 Certificates shall be awarded as per policy of YAI.

17. PHOTOGRAPHY CONSENT

By entering the event competitors automatically grant to the organizing authority the right in perpetuity to make, use, and show from time to time at their discretion, any motion pictures, still pictures and live, taped, or filmed television and other reproduction of them, taken during the period of the event without compensation and without the competitor's approval of such images or any use thereof.

18. LIABILITY AND INDEMNIFICATION

- 18.1 Army Yachting Node, Yachting Association of India and all their officers, members, race officials and volunteers do not accept liability for loss of life or property, or personal injury or damage caused by or arising out of the event. Competitors take part in the event at their own risk (See RRS Rule 3, Decision to Race). Respective sailing clubs need to ascertain sailing proficiency of their sailors.
- 18.2 The establishment of the notice of race and the sailing instructions in no way limits or reduces the complete and unlimited responsibilities of competitors being solely and entirely responsible for the management of their boats before, during and after the championship.
- 18.3 Competitors shall maintain their boats in a safe and seaworthy condition.
- 18.4 A competitor shall be of good health and a competent sailor capable of racing a dinghy/skiff/windsurfing board (as applicable) in open waters in all conditions, including strong winds.
- 18.5 At-fault occurrences to other boats are the responsibility of the competitor. Competitors are not covered by any liability insurance provided by the organizing authority and should provide their own coverage for personal goods and liability protection. The organizing authority recommends that competitors consult their own insurance carriers to ensure they are covered at this event and regarding additional personal liability insurance coverage.
- 18.6 A competitor is advised to have personal accident and health insurance that covers him while attending the event and while racing.
- 18.7 To the fullest extent permitted by law, each competitor agrees to indemnify and hold, the host, YAI, owners, affiliates, officers, employees, agents, members, volunteers, committee persons and race officials, acting in their official capacities, harmless from any claim arising from a competitor's acts or omissions.

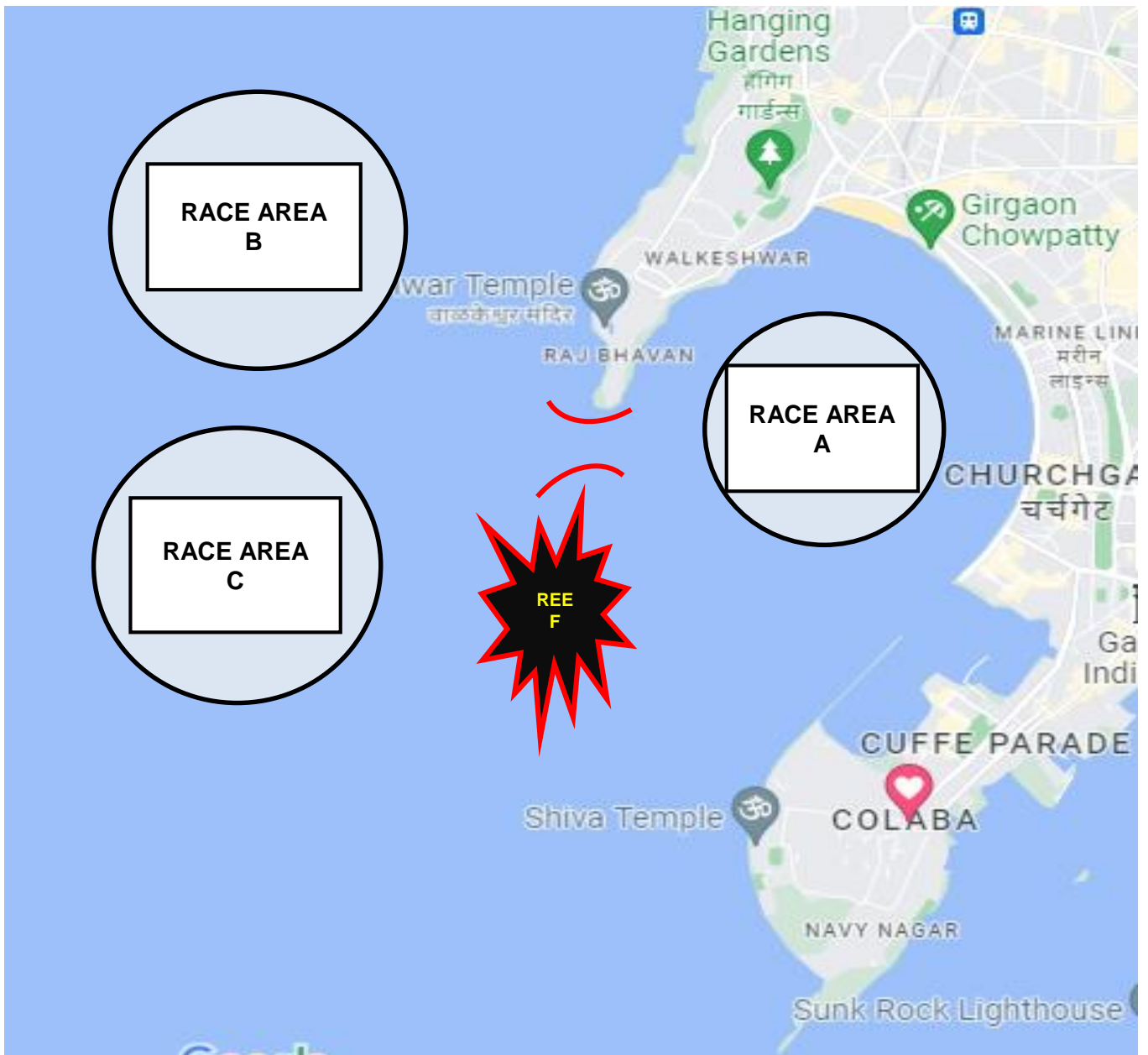
