An event is confirmed once registration opens. Competitors are advised not to make travel arrangements before having received a confirmed registration.

The organizing authority will not be liable for any other expenses incurred.

## 2 RULES

2.1 The event is governed by the rules as defined in The Racing Rules of Sailing (RRS), Appendix WF

https://www.sailing.org/tools/documents/DR2105AppendixWFWingfoilingRacingrulesJune20 21-[27358].pdf

- 2.2 For the Medal Series, Appendix UF, Umpired Fleet Racing WingFoil Edition, applies and changes a number of racing rules. The version that is current when the event begins will be published on the Official Notice Board. This changes RRS 63.7.
- 2.3 The WingFoil Open Class Rules apply (<u>https://wingfoilracing.com/images/documents/CR%20-%20WFO\_20230215.pdf</u>)
- 2.4 Local Sailing Instructions (LSI) will be published and may change or supplement rules in these NoR/SIs.
- 2.5 For purposes of qualification for the ANOC World Beach Games (World Cup Garda), the Qualifying System and Regatta Schedule, Sailing - 2023 ANOC World Beach Games, Bali, Indonesia (Qualifying System), shall apply. See <u>https://www.anocolympic.org/documents/</u>.
- 2.6 A WingFoil shall neither make radio transmissions while racing nor receive radio communications not available to all WingFoil, except in an emergency or when using equipment provided by the organizing authority. This restriction also applies to mobile telephones.
- 2.7 In all rules governing the event;
- 2.7.1 The terms 'rider', 'competitor', 'crew', and 'athlete' mean a person competing, or intending to compete, in the event;
- 2.7.2 [SP] denotes a rule for which a standard penalty may be applied by the race committee or technical committee without a hearing as per NoR/SI 18.6.

- 2.7.3 [NP] denotes a rule that shall not be grounds for protest by a WingFoil and for which the protest committee may refuse to hold a hearing. This changes RRS 60.1(a) and 63.1.
- 2.8 If there is a conflict between languages the English text will take precedence.
- 2.9 Changed Rules:
- 2.9.1 RRS Appendix WF.3.31 is deleted. Standard RRS 31 applies.
- 2.9.2 Actions by event officials to implement COVID-19 guidance, protocols or legislation, even if they later prove to have been unnecessary, will not be grounds for redress. This changes RRS 62.1(a).

### **3 EVENTS, QUOTAS AND ELIGIBILITY**

3.1 There will be competition in the following events, classes and categories:

- 3.1.1 Exceptions to the maximum quota may be made at the discretion of the organizing authority.
- 3.1.2 The Organizing Authority may cancel the event if the minimum number of entries has not been reached 14 days before the on-site registration day of the event. Competitors will be notified of event cancellation by email and posting on the class website. Entry fees will be refunded.
- 3.2 Age divisions will be established if a division has 5 or more entries for the following age groups:

U19 (born 2005 and after)

Master (born 1987 and before)

Grand Master (born 1977 and before)

On 1 March 2022, World Sailing published the following recommendations in reaction to the situation in Ukraine: <a href="https://www.sailing.org/2022/03/01/world-sailing-statement-6/">https://www.sailing.org/2022/03/01/world-sailing-statement-6/</a>. To help preserve the integrity and safety of the regatta, no entries from wingfoils representing Russia or Belarus will be accepted.

#### **4 ENTRY AND REGISTRATION**

- 4.1 Competitor registrations shall be made via <u>https://wingfoilracing.com/events-results/register</u>
- 4.2 Entries will be accepted on a first come-first served basis.
- 4.3 Registration fees per competitor will be listed in the registration system (all plus credit card fees) and are not refundable except if the event is cancelled
- 4.4 No support boats are allowed on the field of play and adjacent waters without prior registration and approval.
- 4.5 Competitors shall provide the following documentation prior to completing registration formalities on site:
  - Proof of Entry Fee payment;
  - Proof of age;
  - Parental/legal guardian consent for those under the age of 18; and
  - Medical Treatment Permission for those under age of 18 or on their parent's medical insurance policy.

- 4.6 [NP] [SP] [DP] Athletes, support personnel and team leaders shall personally sign the registration form at the Race Office during the times scheduled.
- 4.7 An entry is not complete until the competitor has fully paid the registration fee and has completed registration at the venue.

#### **5** SCHEDULE

5.1	The schedule for each event will be as follows (all times are local):

- 5.2 Each racing day may be separated into two sessions.
- 5.3 Six races are scheduled per racing day.
- 5.4 Not more than eight races will be raced per day.
- 5.5 A skippers meeting will be held daily 1 hour before the first scheduled warning signal.
- 5.6 Addendum 3 shows the general race schedule and the number of scheduled races. The Local Sailing Instructions will specify the times for the first warning signal of each session for each day.
- 5.7 Any change to the times of the first warning signal will be posted no later than 21:00 on the previous evening of any race affected.
- 5.8 On the last day of racing no warning signal will be made after 1700 hours.

#### **6 FORMAT AND SCORING**

- 6.1 One race for all fleets is required to be completed to constitute an event.
- 6.2 The format will be an Opening Series followed by
  - (a) a Golden Ticket Race and a Medal Series for the top 10 wingfoils when there are 10 or more entries, or
  - (b) a Medal Series for the top 4 wingfoils when there are less than 10 entries.
- 6.3 The Opening Series may be separated into a Long Distance Series, Qualifying Series and Final Series depending on entry numbers.
- 6.4 A wingfoils score for a Long Distance race will be divided by the number of fleets in the event rounded to the nearest 10th of a point (0.05 to be rounded upward).
- 6.5 When there is a Final Series, it is scheduled for the penultimate racing day.
- 6.6 After the Long Distance Race (or, if the Long Distance Race cannot be completed in the first session) and when the format includes a Qualifying Series:
  Wingfoils will be assigned to fleets yellow, blue, red etc., of, as nearly as possible, equal size

and ability. Assignments will be made by the race committee based on the wingfoils' standing at the end of the Long Distance series regardless of pending hearings and will be posted at

least 30 minutes before the first warning signal is made. Those assignments will not be grounds for redress. This changes RRS 62.1(a).

Wingfoils will be reassigned to fleets after each session. If all fleets have completed the same number of races, wingfoils will be reassigned on the basis of their ranks in the series. If all fleets have not completed the same number of races, the series scores for reassignment will be calculated for those races, numbered in order of completion, completed by all fleets. For three fleets, and similarly for any other number, reassignments will be made as follows:

First	Yellow
Second	Blue
Third	Red
Forth	Red
Fifth	Blue
Sixth	Yellow
Seventh	Yellow

etc.

Reassignments of fleets will be based on the standings available 30 minutes after the last finisher of the previous session, regardless of pending hearings and unanswered scoring inquiries.

If all fleets have not completed the same number of races by the end of a session, scores for the most recent races will be excluded so that all wingfoils have the same number of race scores.

RRS A5.2 is changed so that the scores are based on the number of wingfoils assigned to the biggest fleet.

6.7 If 4 or more races are completed by each fleet at the end of the Qualifying Series:

Wingfoils will be assigned to fleets gold, silver, bronze etc., based on their ranking at the end of the Qualifying Series. There will be the same number of fleets in in the Final Series as there were in the Qualifying Series. The Final Series fleets will have, as nearly as possible, equal size and the Gold fleet will not be smaller than any other fleet. Wingfoils with the best Qualifying Series ranks will race all Final Series races in fleet gold, wingfoils with the next-best Qualifying Series ranking will race in fleet silver, etc.

Any recalculation of rankings after wingfoils have been assigned to Final Series fleets will not affect the assignments except that a redress decision may promote a wingfoil to a higher fleet.

- 6.8 A wingfoil's Opening Series score will be the total of her race scores except that:
  - when from 4 to 6 races have been completed her worst score will be excluded;
  - when from 7 to 10 races have been completed her two worst scores will be excluded;

• when 11 or more races have been completed her three worst scores will be excluded; however, not more than one final series score may be excluded when less than five final series races have been completed, and not more than two final series scores may be excluded when five or more final series races have been completed. This changes RRS A2.

- 6.9 For the Opening Series standings, wingfoils will be ranked in the order of the wingfoils competing in fleets gold, silver, bronze, etc. This may not apply to a wingfoil disqualified under RRS 6 or 69.
- 6.10 The Golden Ticket Race and the Medal Series will be sailed when 7 or more Opening Series races have been completed.
- 6.11 The first ranked wingfoil in the Opening Series will qualify to the Grand Final carrying forward two match points.
- 6.12 The second ranked wingfoil in the Opening Series will qualify to the Grand Final carrying forward one match point.
- 6.13 The third and fourth-ranked wingfoils in the Opening Series will qualify to the Semi-Final.
- 6.14 The fifth and sixth-ranked wingfoils in the Opening Series will qualify to the Quarter-Final.
- 6.15 Wingfoils ranked seventh to ninth in the Opening Series will qualify to the Repechage Race.
- 6.16 Wingfoils ranked tenth to last in the Opening Series will qualify to the Golden Ticket Race.

- 6.17 The Golden Ticket Race will be a Long Distance race for wingfoils ranked from tenth to last in the opening series. The top ranked wingfoil qualifies to the Repechage Race. The rest are scored according to their finishing order in their respective Final Series fleets. The score of the Golden Ticket Race cannot be excluded.
- 6.18 The Medal Series will be divided into four stages: Repechage Race (RR), Quarter-Final (QF), Semi-Final (SF) and Grand Final (GF). Wingfoils advance from one stage to the other until the Grand Final.
- 6.19 The top two ranked wingfoils from the Repechage Race qualify to the Quarter-Final.
- 6.20 The top two ranked wingfoils from the Quarter-Final qualify to the Semi-Final.
- 6.21 The top two ranked wingfoils from the Semi-Final qualify to the Grand Final.
- 6.22 If there is a tie between wingfoils, they will be ranked in order of their positions in the previous stage.
- 6.23 The race committee may cancel the Golden Ticket, Repechage, Quarter Final and/or Semi Final races if the completion of the Medal Series is in jeopardy.
- 6.23.1 If the Golden Ticket Race is cancelled, the wingfoil ranked 10 in the Opening Series will qualify to the Repechage Race.
- 6.23.2 If the Repechage, Quarter Final and/or Semi Final races are cancelled, wingfoils ranked 3 and 4 in the Opening Series will qualify to the Grand Final.
- 6.24 Grand Final
- 6.24.1 The Grand Final will continue until one wingfoil collects three match points. The wingfoil with the lowest race score collects a match point.
- 6.24.2 Wingfoils in the Grand Final will be ranked in order of the number of match points, from highest to lowest.
- 6.24.3 If there is a tie in match points between two or more wingfoils, they will be ranked in the order of their finishing positions in the last race. Any remaining ties shall be broken by using the tied wingfoils' scores in the next-to-last finals race and so on. If a tie remains, they will be ranked in order of their opening series ranking. This changes RRS A8.
- 6.25 The winner of the Grand Final is the winner of the event. The top ten are ranked as follows:

1	1 <sup>st</sup> place Grand Final
2	2 <sup>nd</sup> place Grand Final
3	3 <sup>rd</sup> place Grand Final
4	4 <sup>th</sup> place Grand Final
5	3 <sup>rd</sup> place Semi-Final
6	4 <sup>th</sup> place Semi-Final
7	3 <sup>rd</sup> place Quarter-Final
8	4 <sup>th</sup> place Quarter-Final
9	3 <sup>rd</sup> place Repechage Race
10	4 <sup>th</sup> place Repechage Race

If the Grand Final is not completed, wingfoils will be ranked in positions 1-4 according to the current standing of the Grand Final.

- 6.26 If a stage cannot be completed, wingfoils are ranked in the order of their finishing position in the previous stage. If the Repechage Race cannot be completed, wingfoils are ranked in the order of their position after the Opening Series.
- 6.27 Wingfoils not qualified for the Medal Series will be ranked from place 11 and on, according to their Opening Series score plus their Golden Ticket Race score. This changes RRS A2.
- 6.28 Wingfoils in the Medal Series will be ranked in front of the remaining wingfoils competing in the gold fleet, which will be ranked in front of wingfoils competing in subsequent fleets etc. This may not apply to a wingfoil disqualified under RRS 6 or 69.
- 6.29 A wingfoil that came to the starting area but did not start or did not finish will be scored points for the finishing place one more than the number of wingfoils that finished and were not disqualified or retired. This changes RRS A5.

## 7 WORLD CUP SERIES SCORING WORLD CHAMPIONSHIP TITLE

- 7.1 For each event, a competitor will receive point(s) equal to (101 points minus their finishing position) multiplied by the event grade.
- 7.2 Competitors not competing in an event will receive 0 points for that event.
- 7.3 The World Championship Series score of a competitor will be the total of her best X scores in the calendar year. X is the number of World Cup events in the calendar year.
- 7.4 The competitor with the highest World Championship Series score after the last World Cup event of the year will be declared World Champion. All others will be ranked accordingly.
- 7.5 If there is a tie in the World Championship Series ranking, it shall be broken according to RRS A8, replacing 'race scores' with 'event scores'.

### 8 COURSES AND RACING AREAS

- 8.1 The diagrams in Addendum 1 show the courses, the course designations, the approximate angles between legs, the order in which marks are to be passed, and the side on which each mark is to be left.
- 8.2 Additional courses and the course for Long Distance / Downwinder may be published in the Local Sailing Instructions.
- 8.3 Courses will not be shortened. This changes RRS 32.
- 8.4 NoR/SI 26 shows further venue related information.

#### **9 STARTING AND FINISHING**

- 9.1 To alert WingFoils that a sequence of races will begin soon, the orange starting line flag will be displayed with one sound at least five minutes before a warning signal is made.
- 9.2 The starting line will be between a staff displaying an orange flag on the race committee vessel and either:
  - a) the course side of the port-end inflatable mark, or
  - b) a staff displaying an orange flag on the race committee vessel on the port end.
  - This changes RRS Race Signals.
- 9.3 A WingFoil starting later than 1 minute after her starting signal will be scored Did Not Start. This changes RRS A5.1 and A5.2
- 9.4 The finishing line will be between a staff displaying a blue flag and the course side of the nearby leeward finishing mark. This changes RRS Race Signals.
- 9.5 [DP] When a starting sequence is in progress, WingFoils whose warning signal has not been made shall avoid the starting area. The starting area is defined as an area 100 meters from the starting line and marks in all directions.
- 9.6 [DP] WingFoils that have finished shall sail clear of the finish area.
- 9.7 For the Long Distance races a Rabbit start will be used: at the starting signal a Rabbit (a vessel displaying a white wingfoil class flag towing a small marker buoy) will proceed at high and constant speed from the starting mark to the race committee vessel. The starting line will be between the course side of the starting mark and marker buoy towed by the Rabbit.
- 9.7.1 A Wingfoil shall not sail between the race committee vessel and the marker buoy towed by the Rabbit from one minute before her starting signal until she starts. If a wingfoil breaks this

rule and is identified, she shall be disqualified without a hearing, even if the race is restarted or resailed, but not if it is postponed or abandoned before the starting signal. Her disqualification shall not be excluded in calculating her series score. This changes RRS 36 and A5.

#### **10 TIME LIMITS AND TARGET TIMES**

10.1 Time limits and target times, in minutes, are as follows:

- 10.2 If no WingFoil rounds Mark 1 within the Mark 1 time limit, the race shall be abandoned.
- 10.3 Not meeting the target time will not be grounds for redress. This changes RRS 62.1(a).
- 10.4 WingFoils not finishing within the Finish Time Window (time after the first WingFoil starts, sails the course and finishes) will be scored DNF without a hearing. This changes RRS 35, A5.1 and A5.2

## 11 [DP] [SP] [NP] IDENTIFICATION AND ADVERTISING

- 11.1 When provided by the organizing authority, WingFoils and competitors shall carry, display or wear the following as instructed:
- 11.1.1 Competition bibs for all competitors with an individually assigned competition number, worn as intended over all other clothing and equipment at any time when afloat.
- 11.1.2 Event leader bibs with an individually assigned competition number, worn as intended over all other clothing and equipment at any time when afloat.
- 11.1.3 Event advertising
- 11.1.4 Cameras and other media equipment
- 11.1.5 Tracking and timing equipment.
- 11.2 WingFoils shall not display advertising from previous events.

### 12 COMMUNICATION WITH COMPETITORS

- 12.1 Addendum 2 shows the links to the official notice board and online management platform online
- 12.2 Complementary information will be made available via Telegram Messenger at <u>https://t.me/+DuasGIBFssFjOGVk</u>
- 12.3 The location of the official flagpole will be described in the LSI.

- 12.4 When flag AP is displayed ashore, '1 minute' is replaced with 'not less than 20 minutes' in the race signal AP. This changes RRS Race Signals.
- 12.5 The LSIs will be posted on the official notice board no later than the first skippers meeting.

## 13 CHANGES TO NOTICE OF RACE AND SAILING INSTRUCTIONS

Any change to the NoR/SI and the LSI will be posted 30 minutes before it will take effect.

## 14 [DP] [SP] [NP] SAFETY REGULATIONS

- 14.1 When Flag G is displayed ashore, wingfoils returning ashore shall either personally check in at the official flag pole where the flag is displayed, or be reported as safe by their support personnel.
- 14.2 WingFoils not leaving the launching area for a scheduled race shall promptly notify the race committee.
- 14.3 A helmet to the minimum standard EN1385 or EN1077 or equivalent with at least 300 square centimeters of the exterior surface in a high visibility colour shall be worn at all times when afloat, except briefly while changing or adjusting clothing or personal equipment, or during on-water interviews.
- 14.4 Body protection (Impact vest) which may also act as a personal flotation device in accordance with CR C.3.2(b) shall be worn at all times when afloat, except briefly while changing or adjusting clothing or personal equipment.

## 15 [DP] [NP] CODE OF CONDUCT

- 15.1 Competitors and support persons shall comply with any reasonable request from an event official. Non-compliance may be misconduct.
- 15.2 WingFoils not racing shall remain clear of areas where WingFoils are racing and any official boat.

## **16 NOT IN USE**

### **17 INTERNATIONAL JURY**

An international jury may be appointed in accordance with RRS 91(b). Its decisions will be final as provided in RRS 70.5.

## **18 HEARING REQUESTS AND PENALTIES**

- 18.1 Hearing request forms are available through the online platform (see Addendum 4)
- 18.2 The protest time limits will be described in the LSI.
- 18.3 Notices will be posted within 15 minutes of the protest time limit to inform competitors of hearings in which they are parties or named as witnesses. Hearings will be held beginning at the time posted. Hearings may be scheduled to begin up to 15 minutes before the end of the protest time limit.
- 18.4 Penalties for breaches of the ER, STR, AMR, RRS 50, RRS 78.1, class rules or rules in the NoR and SIs marked [DP], should the case go to a hearing, are at the discretion of the protest committee.
- 18.5 For breaches of NoR/SI marked [SP], the race committee or technical committee may apply a standard penalty without a hearing to the race closest in time to the incident. The scores of other WingFoils shall not be changed; therefore, two WingFoils may receive the same score. However, the race committee or technical committee may protest a WingFoil when they consider the standard penalty to be inappropriate. A WingFoil that has been penalized with a standard penalty can neither be protested for the same incident by another WingFoil nor can another WingFoil request redress for this race committee action. This changes RRS 60.1, 63.1 and Appendix A5.
- 18.6 RRS 62.2(a) and 66.2(a) also apply on the last day of the Qualifying Series and the last day of the Opening Series.

## **19 SUPPORT PERSONS** (INCLUDING SUPPORT BOATS)

- 19.1 Support persons shall register with the local organizing authority at registration day and shall comply with the local legislation and the Support Team Regulations. The local organizing authority may refuse registrations or accept later registrations at their discretion.
- 19.2 Support boats shall be registered in advance as per NoR/SI 4.
- 19.3 A support boat includes any boat that is under the control or direction of a support person, including any person gathering data that may be used at a later time.
- 19.4 Support boats shall clearly display their national 3 letter country code and other identification if provided by the organizing authority. The minimum height for the letters shall be 200 mm. and visible from both sides of the vessel.
- 19.5 Except when participating in rescue operations as requested or instructed by the race committee, support team personnel shall remain in the area defined in Addendum 2 from the time of the preparatory signal for the first group to start until all WingFoils have finished or retired or the race committee signals a postponement, general recall or abandonment.

## 20 [DP] [NP] PRIZES, VICTORY CEREMONY

- 20.1 Medals will be awarded to the first four competitors in each event.
- 20.2 Prize money will be awarded to maximum the top 50% of the competitors in an event as follows.
- 20.2.1 10.000 EUR / USD prize money:

20.3 If a competitor who finished in the top 3 leaves the event before the conclusion of the victory ceremony or, if other competitor, leaves the venue before the day before the victory ceremony, IWSA may exclude that competitor from the next Championship or impose any similar sanction.

## 21 [NP] [DP] INSURANCE

- 21.1 Each competitor, person in charge under RRS 46 and boat driver shall hold a valid insurance certificate showing proof of third-party liability coverage.
- 21.2 The Organizing Authority is not responsible for verifying the status or validity of certificates.

### **22 DOPING CONTROL**

Competitors are reminded of the World Sailing rules and regulations concerning the use of banned methods and substances, which are contained in the World Sailing Anti-Doping Code. Drug testing may take place during this event.

## **23 RISK STATEMENT**

- 23.1. In cases of force majeure or on grounds of administrative orders or for safety reasons, the organizing authority is entitled to make changes in the realization of the event or to cancel the event. This does not constitute any liability by the organizer towards the participant, if the reasons for the changes or the cancellation do not result from a wilful or grossly negligent behaviour of the organizer.
- 23.2 In case of a violation of obligations that do not constitute primary or material contractual duties (cardinal obligations), the liability of the organizer for financial and property damages incurred by the participant during or in connection with the participation in the event and resulting from a conduct of the organizer, IWSA, the involved classes and their representatives, servants or agents (including but not limited to race committee , protest committee and technical committee), is restricted to damages that were caused willfully or grossly negligent. When a violation of cardinal obligations occurs due to minor negligence, the liability of the organizer is limited to foreseeable, typical damages.
- 23.3 Competitors and support team participate in the event entirely at their own risk and they are reminded of the provisions of RRS 3, Decision to Race. WingFoiling is by its nature an unpredictable sport and therefore involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:
  - They acknowledge that there are risks involved in the Event. They fully realise the dangers of participating in the Event, and fully assume the risks associated with their participation and their wellbeing and safety during and after the Event.
  - They understand and acknowledge that the Event organisers (including all officials and event volunteers) provide no warranties, regarding their wellbeing and safety.
  - They acknowledge that participating in this event may involve a test of a person's physical and mental limits and carries with it the potential for death, serious injury, and property loss. The risks include, but are not limited to, those caused by the elements, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, lack of hydration, and actions of other people including, but not limited to, participants, volunteers, officials, and/or producers of the event.
  - They agree that to the extent permissible by law, World Sailing, the International Wing Sports Association, their classes, the event organisers (including all officials and event volunteers), the sponsors and other parties associated with the Event, have no liability to them whatsoever for any direct or indirect loss, (including, but not limited to injury or death) sustained by them during or in any way related to their participation in the Event.
  - They WAIVE, RELEASE, AND DISCHARGE from any and all liability, including but not limited to, liability arising from the negligence or fault of the entities or persons released, for their death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to them including their traveling to and from this event, THE FOLLOWING ENTITIES OR PERSONS: World Sailing, The International Wing Sports Association, their classes, the event organisers (including all officials and event volunteers), the sponsors and other parties associated with the Event, employees, volunteers, representatives, and agents, and the event holders, sponsors, and volunteers;
  - They INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the entities or persons mentioned in the above paragraphs from any and all liabilities or claims made as a result of participation in this event, whether caused by the negligence of release or otherwise.
  - They have taken medical advice on any pre-existing medical conditions and confirm that it is medically safe for them to participate in the Event.

- They are responsible for the safety of themselves, their equipment and their other property at any time.
- They are satisfied that their equipment is in good order, equipped to compete in the event and they are fit to participate;
- They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- They consent to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during this event.
- They acknowledge that the provision of a race management and rescue team, judges, umpires and other officials and volunteers by the organizer does not relieve them of their own responsibilities;
- They acknowledge that the provision of rescue craft cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.

## 24 [DP] [NP] MEDIA RIGHTS

By participating in the event, competitors and support personnel automatically grant to the organizing authority, IWSA, all involved classes, and their sponsors the right in perpetuity to make, use and show, from time to time at their discretion, any motion pictures and live, taped or filmed television and other reproductions of the athlete during and after the period of the event without compensation.

#### **25 DATA PROTECTION AND PRIVACY**

With registration the competitor or support person agrees on data usage as defined in this data protection and privacy notice. See IWSA Privacy Notice in Addendum 4.

Reference is made to data protection of personal information and data. Any personal information and data given to the organizers will be used only as follows:

- (a) All data regarding participating athletes, support personnel and their WingFoil will be processed and archived for the purpose of this event and events of similar nature that might be of interest to the participant.
- (b) Personal information contains the participant's real name, date of birth, home club, boat type. boat number, address data, mobile phone, email address and emergency contact information. In particular, results, calculatory and visual analyses, position monitoring and race analyses will be published with reference to the competitors' names.





## ADDENDUM 4 PRIVACY NOTICE

The International Wing Sports Association takes the security and privacy of personal information very seriously. This Privacy Notice set out the basis on which any personal data obtained as a result of participating in this event will be processed. All processing will be in accordance with the applicable data protection legislation for the purposes for which the information was submitted.

If and insofar as the IWSA and the local organizing authority of an event records, processes and/or stores any data which is subject to data protection laws, the compliance with all corresponding laws and regulations is incumbent upon the local organizing authority.

#### 1. About this Privacy Notice

- This is the privacy notice ("**Notice**") of the International Wing Sports Association, Avenue des Alpes 62, 1820 Montreux, Switzerland ("**IWSA**", "we", "us", "our").
- This policy explains when and why we collect personal information about event participants, how we use it and how we keep it secure and your rights in relation to it. We will post any changes we may make to this Notice on our Website or communicate them to you by email.
- We may collect, use and store your personal data, as described in this Privacy Notice and as described when we collect data from you.
- We reserve the right to amend this Privacy Notice from time to time without prior notice. You are advised to check our webistes regularly for any amendments (but amendments will not be made retrospectively).
- We will always comply with the General Data Protection Regulation (GDPR) when dealing with your personal data. For the purposes of the GDPR, we will be the "controller" of all personal data we hold about you.
- The Notice currently in place dates of 01<sup>st</sup> May 2021.

#### 2. What personal data do we collect from you?

- We collect personal data that you provide to us in relation to registering for and participating in IWSA events, such as by filling out a registration form or signing up for an email distribution list. Such personal data may consist of:
  - contact information (such as name, physical address, email address, and mobile or other telephone number);
  - gender, age/date of birth
  - World Sailor ID, sponsor information
  - emergency contact information
- Any information that you may provide voluntarily by filling in forms for your registration to an event, or by otherwise contacting IWSA.

#### 3. How we protect your personal data

- In order to manage the participation in this event and other events, it may sometimes be necessary for us to transfer your personal data outside the European Union. However we will only do so in accordance with the GDPR. That is most likely to involve either approval by the EU Commission that the country to which your data is being transferred provides adequate protection for personal data or on the basis of standard clauses, required by the EU, with the organisation to which we are transferring your data.
- We have implemented generally accepted standards of technology and operational security in order to protect personal data from loss, misuse, or unauthorised alteration or destruction.
- Please note however that where you are transmitting information to us over the internet this can never be guaranteed to be 100% secure.
- For any payments which we take from you online we will use a recognised online secure payment system.

• We will notify you promptly in the event of any breach of your personal data which might expose you to serious risk.

#### 4. For which purposes do we process your personal data?

- We process your personal data for the following purposes:

#### 5. To whom do we disclose and transfer your personal data?

- We will never sell your personal data. We will not share your personal data with any third parties without your prior consent (which you are free to withhold) except where we are required to do so by law or as set out in the paragraph above or in paragraphs 5.2 and 5.3 below.
- We may pass your personal data to third parties who are service providers, agents and subcontractors to us for the purposes of completing tasks and providing services to you on our behalf (e.g. managing protests, calculating results and providing tracking information and analysis, media productions). We do this for the purpose of our legitimate interests in operating this event and for performing our responsibilities with you. However, we disclose only the personal data that is necessary for the third party to deliver the service and we require them to keep your information secure and not to use it for their own purposes. It is possible that third parties may themselves engage others (subprocessors) to process your data. Where this is the case third parties will be required to have arrangements with their sub-processor(s) that ensure your information is kept secure and not used for their own purposes.
- We may disclose your personal data to the following recipients or categories of recipients acting on our behalf and/or as partners (processors), limited to the purpose of the execution of their obligations, which are contractually bound to adhere to an adequate level of data protection when processing your personal data:

- We may internationally transfer your personal data, including to countries that are not considered providing an adequate level of data protection by the relevant regulatory bodies, for example to countries not considered by the European Commission or the Swiss Federal Data Protection and Information Commissioner to be providing such level. In such case, we ensure the adequate protection of your personal data by having the recipients adhere to binding contractual obligations in accordance with applicable standards approved by the
